Our fees will be agreed upon as a fixed sum at the start of your case or based on how much time it takes to deal with your case.

VAT

Initial Consultation

We offer an initial one hour no-obligation consultation, which can either be in person or remotely via telephone, zoom, Team, exchange of email or any other agreed online platform. This is an opportunity for you to seek initial advice on your case, get a second opinion, or gather sufficient information to take the case forward yourself. The cost of this service is between £80-£150 depending on the year of experience of the solicitor or caseworker handling the matter.

Our Charges

Unless we agree otherwise, we charge an agreed fixed fee for specific work, usually agreed upon taking initial instructions from you. Our average fixed fee starts from £500. However, in circumstances where we cannot estimate a fixed fee, we will provide our fees based on an hourly rate and give you an approximate time to complete your matter.

Flexibility in our Pricing

We constantly explore the cost-benefit with clients and, in many cases, offer flexible payment options. The precise cost of our services will depend on the particular circumstances of your case. Where the application or matter is relatively straightforward it is likely that the fees will be at the lower end of the relevant spectrum. Where there are complex factors including level of urgency ,the fees may reach or in some cases exceed the upper end. We will agree on costs with you in advance and are happy to discuss funding options.

Fee Revision

We will only charge you the fees we initially agreed to. In some circumstances, we may need to revise or recalculate our fees, which may be the case if your matter becomes more complex and takes more hours than the initially estimated hours, if your instructions change to the extent that it causes your matter to become more complex or take more time to deal with, or if unforeseen or exceptional circumstances arise, including where your matter is required to be carried out in an emergency or out of hours.
