- You are also informed to fill in the online "Mauritius All-In-One Travel Digital Form" at most Seventy-two (72) hrs prior to undertake travel to Mauritius. The form is available on <https://safemauritius.govmu.org>.
- In case you do not intend to come to Mauritius for study, you should immediately inform this office in writing.
- You are advised to produce this letter to the Immigration Control Officer at the points of entry into Mauritius in order to facilitate your immigration clearance.
