Eligibility Criteria

- *Students Can Apply With or Without IELTS/ PTE*
- *Gap Acceptable- We cover 5 TO 6 years gap and make relevant experience(work Experience) from MNC's companies.*
- *3. Refused Candidate from any country - Are welcome except Spain*



Eligibility Requirements:

1. **Acceptance Letter:** You must have an acceptance letter from a recognized educational institution in Spain confirming your enrollment in a full-time course.
2. **Proof of Financial Means:** You must demonstrate that you have sufficient financial means to support yourself during your stay in Spain. This can be shown through bank statements, scholarship letters, or sponsorship letters.
3. **Health Insurance:** You need to have health insurance that covers medical expenses in Spain.
4. **No Criminal Record:** You must have no criminal record. A police clearance certificate from the authorities in India is usually required.
5. **Medical Certificate:** You must provide a medical certificate proving that you do not suffer from any diseases that could pose a public health risk.
6. **Visa Application Form:** Complete the National Visa application form.
7. **Passport:** Your passport must be valid for at least three months beyond your planned stay in Spain and have at least two blank pages.
8. **Passport-Sized Photos:** You will need recent passport-sized photographs that meet the Spanish visa photo requirements.

Application Process:

1. **Prepare Documents:** Gather all required documents, including the completed visa application form, acceptance letter, financial proof, health insurance, police clearance certificate, medical certificate, passport, and photographs.
2. **Submit Application:** Submit your visa application and supporting documents to the Spanish Consulate or Embassy in India. You may need to schedule an appointment in advance.
3. **Pay Visa Fee:** Pay the required visa application fee. The fee amount may vary, so check the latest fee structure on the official website of the Spanish Embassy or Consulate.
4. **Attend Interview:** You might be required to attend an interview at the Spanish Consulate or Embassy.
5. **Wait for Processing:** Visa processing times can vary, so apply well in advance of your intended travel date. Processing can take several weeks.
6. **Receive Visa:** If your application is approved, you will receive your student visa, which allows you to enter Spain. Once in Spain, you may need to apply for a residence permit.

Important Points:

- **Visa Validity:** The student visa is typically issued for the duration of your course. If your course is longer than six months, you will need to apply for a student residence card (TIE) within a month of arriving in Spain.
- **Work Permit:** As a student, you may be allowed to work part-time (up to 20 hours per week) during your studies. However, you will need a
