Detective Andrew Martinez, a peace officer for the City and County of Broomfield, being duly sworn says that there is probable cause for the warrantless arrest of the above-named defendant for the charge(s) stated above, arising out of incidents occurring at 3132 Promontory Loop, City and County of Broomfield, State of Colorado, on December 14, 2023, at about 12:02 PM, and that the following facts are true and correct to the best of his knowledge, information, and belief, and support the arrest of the defendant:

On October 31, 2023, Broomfield Police Patrol Officer King fielded the report of Harassment at 3132 Promontory Loop, within the City and County of Broomfield, State of Colorado (reference Broomfield case 23-58070). Officer King reported that Kristil Krug was in an intimate relationship with Jack Anthony Holland about 20 years ago. Over the past 20 years, Jack Anthony Holland has contacted her multiple times. Each time, Jack Anthony Holland has proposed they have a sexual encounter or meet in person. There is often rude comments included. Kristil has never reported these communications prior because Jack Anthony Holland stopped communication when Kristil did not respond. The communication began again on October 02, 2023, and this time the escalation and communication frightened Kristil for the safety of herself and her family.

On November 02, 2023, this case was assigned to Detective Martinez. He reviewed the case report and submitted digital evidence. On November 07, 2023, Detective Martinez was able to interview Kristil and learned the following:

Kristil and Jack Anthony Holland dated for a short time during college, between the summer of 1999 and the fall of 2000. Kristi ended the relationship. Their break-up was relatively uneventful and Kristil moved on. Kristil then met her husband, Daniel Krug, a few years later and has been married since 2007.

Since the breakup with Jack Anthony Holland, Kristil has received contact multiple times over the years. The contact is via email, social media, or phone. The first contact after their breakup was in the fall of 2002. Again in 2005, 2010, around 2016, and the present. Kristil has not seen Jack Anthony Holland in person since shortly after their breakup.

The recent contact began on October 02, 2023. Kristil received a text message that stated, "Hi Kristil ItsAnthony. Hope its ok i looked you up. I go to boulder every few weeks and thought we could hook up. U game?" Kristil did not respond. On October 03, 2023, Jack Anthony Holland sent additional text messages saying, "r u there? U should say yes when I offer pity fuck Whatev saw ur pies u got fat Bet ur loser husband wont fuck ur fat cunt dumb cunt u should kill urself Dont waste my time." Kristil did not respond.

On October 31, 2023, Kristil received an email from _____ stating the following: This ur husband? Drives like slow old lady Cant believe you wanna suck his dick but not mine He needs to drive safe. Dont wanna clear rubber hose in his tailpipe" There was an attached photo in the email; which was of Kristil's husband exiting his vehicle at his workplace in Glendale, Colorado on October 31, 2023.

On November 03, 2023, Kristil received a "dick-pic" and a text stating, "what do u think?" from

On November 02, 2023, Krstil received an email stating, "Ur license place expired. Gotta fix that. Husbands good. U and ur husband down to eiffel tower?" Kristil verified that her license plate tag had expired at the end of October and needed to be renewed.

On November 04, 2023, Kristi received another text stating, "Are you interested? I'll show more once I know this is the right number." The text was followed by a photo of a shirtless male. Due to the passage of time and grainy photo, Kristil was unable to positively identify Jack Anthony Holland, but it looked similar from her memory. The phone number used to contact Kristil was

On November 04, 2023, Kristil received another text contact but was unsure if it was related to Jack Anthony Holland. The text stated, "Hi! I saw your post on loncanto are you still looking for some men to join you" Kristil responded, "Can you tell me which ad this is for?" The unknown responded, "About you wanting a train" Kristil responded, "I believe someone may have taken out an ad with my number. Could you share the link or title of the ad please?" There was no further communication.

On November 09, 2023, Kristil received another text from , which stated, "saw u at dentist I like clean teeth for my cock. U got so horny an dslutty in my car. So I nitted on urs" Se u soon". Kristil did not respond. Kristil was in fact at the dentist, 11961 Bradburn Blvd, Westminster, Colorado. Kristil left her house on Nov. 09 at 11:30 AM, attended her appointment between 12:00 PM and 1:00 PM, then returned home with no additional stops. Detective Martinez conducted a carrier search online and learned that this phone number is serviced by TextNow, Inc.

Detective Martinez conducted a carrier search online for . This is the number used when Jack Anthony Holland initially contacted Kristil and introduced himself as "Anthony." The online search provided that the number is serviced by Verizon.

On November 13, 2023, Kristil provided the following message she received from Jack Anthony Holland:

"He dont deserve u. U know it. He dont satisfy u. Thats why u keep all ur fuck boys on the side. U a dirty slut and i know how to satisfy u. Admit that noone satisfied u since me. I see u flirting with waiters. Almost begging 4 sex. Lickin ur lips and got ur tits out. Don't know how many fuck boys u kept. But Ill save u. I know he keeping us apart. U dont belong in that big house. U belong with me.,Ill get rid of him and then we can be together. So easy. He got a retard midget on security. They let me park and walk right into his building. Been there for weeks. Give me the signal and he wont come home. Ever married bitch i ever banged wanted to get rid off husbands. Ill do it for us Help me get rid of him then we can be together. Just like u want. Im planning a big bday party for u. Just u me an 20 friends. I know u a dirty slut. Ill treat u right. U

can be slutty with me an ill take u. U dont want the fake married life. U wanna be dirty. Ill save u. Help me get rid of him an we get away. I know he stopping u from talking to me. U dont want him I know u want me."

Once this message was received, the Glendale Police Department was sent to Kristil's husband's work to ensure his safety. Broomfield Police detectives were also dispatched to check Kristil at her residence.

Jack Anthony Holland's most recent address is in Utah and Idaho.

Given the context of the communication, obscene material, and comments, Kristil was very fearful for her safety and the safety of her family. There is evidence and admission of repeated following and surveillance of her and her immediate family. The recent communication has caused her anxiety, hyper-vigilance, and paranoia. She has suffered severe emotional distress.

On December 5, 2023 Kristil received an email from "A Holla" with an email address . The email said "hey gorgeous I cant visit u no more. No more colorado time. My girlfriend dosnt want us talking witout her. She says u will let cops get me aftr u off him but she don't kno u lik ei do. we got a new place wit lots of room on est coast. she said u can move in wit us. we like 3 ways. trash ur husband an come. u know how to get me when he dead".

On December 6, 2023 Kristil received a second email from saying "my othr acct waz watchd. new phones to. be strong com find u."

On December 14, 2023 at about 12:03 p.m. Daniel Krug called Broomfield Police and said he couldn't reach his wife for 3 hours. Daniel told the call taker that he received a text from Kristil stating that he needed to pick up because she needed to meet with Detective Martinez. When Daniel couldn't reach Kristil, he called the police to check on her.

Officer O'Hayre went to the address at 3132 Promontory Loop to check Kristil Krug's welfare. He arrived and saw a female neighbor at the front door of the residence who said she would leave since the police were there to check on Kristil. Officer O'Hayre knocked on the door to the residence. He peaked in the windows and gave a loud knock. Officer O'Hayre went to the garage to see if he could see Kristil's car in the garage. When he got to the garage, he saw that the windows were higher than he could see. He pulled his patrol car onto the driveway to peek in the windows. He looked through the windows and saw a female on the ground and bright red blood smear on the drywall on the south wall of the garage. The female was lying on her back near the stairs from the garage to the house on the southwest corner of the garage. The blood was on the wall near her head and there was also blood on the floor near the female. The female was not moving. Officer O'Hayre used his radio to ask dispatch to send medical to the scene, and asked for his sergeant to come to the address saying he was forcing entry. Officer O'Hayre went to the front door and kicked it once. The door flew open and he went in and to the hallway on the left, towards the garage. Officer O'Hayre went through the main door from

the house to the garage. He saw the female on the ground and saw that there was blood coming from the right side of her head. Officer O'Hayre did not see any weapons anywhere. Officer O'Hayre yelled at her, completed a sternum rub, checked her pulse on her neck and found no pulse. The female felt warm. Officer O'Hayre started CPR. When Officer O'Hayre heard medical personnel arriving, he opened the double garage door so they would have easy access to the female.

Officers searched the house once medical personnel were tending to the female. They did not locate anyone.

Dr. Brody from Good Samaritan Hospital pronounced the female dead at 12:43 p.m.

Officer O'Hayre noticed that she had a substantial wound on the right side of her head near her temple. While medical personnel were caring for the female, they noticed what appeared to be a stab wound on the left side of her chest. Officer O'Hayre saw that the female had her coat on and her purse and a set of keys were near her on the cement.

Officer O'Hayre noticed that the top right corner of the double garage door was damaged, the panel appeared bent and was not flush with the rest of the garage door.

Later, Officer O'Hayre noticed that the doorbell he rang had blue painter's tape over the camera portion of it. Officer O'Hayre also noticed that the front door could only be locked by a deadbolt from the inside and that the deadbolt was not extended. Officer O'Hayre believes that the deadbolt lock on the door was not locked when he kicked it open. Officer O'Hayre also noticed a dog in the residence, secured in a kennel on the first floor of the residence.

Daniel Krug told Detectives that Kristil had recently added motion-activated cameras to the front and rear of her Mazda 3.

Detective Martinez reviewed Officer O'Hayre's body camera footage and recognized the female found on the floor of the garage as Kristil Krug. Detective Martinez verified that he had not scheduled any meeting with Kristil on December 14 and their last communication was on December 07.

Detective Waight initially spoke to Daniel at the police department. He told Daniel he had three Google Nest cameras and a doorbell camera. Daniel was using his cell phone to log into his Google Nest account to show Detective Waight the footage from December 14, 2023, and his account is registered under Daniel. Daniel allowed Detective Waight to look at his phone which he did in an effort to identify possible suspect arrival/departure. While they were looking through the footage, they learned that three of the four cameras were offline for a significant part of the morning of December 14, 2023. Daniel could not provide any explanation for the cameras being offline.

Detective Pihlak was provided information from Detective Martinez from the original stalking case that Kristil was contacted through the Text Now phone number and the Gmail . Detective Pihlak completed and submitted exigent requests to Text Now and Gmail. Text Now responded with limited subscriber data. The originating IP address is with a registration date of October 31, 2023, at 18:40:03 UTC. The email address associated with the Text Now number was

Gmail also responded to the exigent request with limited subscriber data for

number . This data was the same originating IP address as Text Now phone number and the same creation date with a time of 18:28:58 UTC.

Using Google, Detective Pihlak looked up the IP address . This IP address came back to the State of Colorado General Government in Greenwood Village. This was similar to where Dan works. Officer Holt provided Detective Pihlak with the contact information to Dan's supervisor, Greg Stasinos. Detective Pihlak contacted Greg requesting information into this IP address. Greg contacted IT Director Travis Tiller with the CDPHE. They confirmed this was Dan's work address (4300 Cherry Creek Dr South, Glendale, Colorado) and the IP address was an external facing NAT IP. This was described as an open public network Wi-Fi address that had limited logging capabilities. Based on this information, Daniels's personal and work cell phones were seized prior to him leaving the Broomfield Police Department.

Officers spoke to Sgt. Ormond of the Utah County Sheriff's (Eagle Mountain Division), who spoke with Anthony and confirmed he had been in Utah. He had been at Kohl's Dept at 1:40 PM (Utah time) and provided items he had purchased to Officers. Anthony's current wife was also with him. His vehicle also appeared on license plate readers in the area of Anthony's residence in Utah.

Detective Martinez and Detective King-Sullivan interviewed Daniel at the police department on December 14, 2023, at about 4:26 p.m. Before speaking to him, Detective Martinez advised him of his Miranda rights using an adult advisement/waiver form. He agreed to speak with them both verbally and by signing the form. In summary, Daniel denied killing Kristil or having anything to do with her death.

During the interview with Daniel, he explained that he left his house about 20 minutes later than usual because he was having unexplainable stomach trouble; he implied that he was diarrheal. Kristil had left the house to take the kids to school, and when she came home she interacted with Daniel. At that time, Kristil inquired about him still being at home because it was abnormal. Daniel denied any argument or physical altercation between them. Daniel said if the police were not going to arrest him, he wanted to leave. Daniel was allowed to leave without issue and he was provided transportation.

**Arrangements were made for Daniel and Kristil's children
to stay with**

. Broomfield Health and Human Services (HHS) personnel established a safety plan for the children

**. HHS Personnel also informed
that the children would be asked to participate in a forensic interview in the near future. An autopsy was completed on December 15, 2023, starting at 9:00 a.m. Preliminary information from the autopsy is that Kristil has two or more blunt-force trauma wounds on the back of her head and one stab wound on the left side of her chest.**

On December 15, 2023, Detective Pihlak obtained a search warrant for Daniel's work office at 4300 Cherry Creek Dr South, Glendale, Colorado, Office A5023. Detective Martinez and Ramzauskas served the search warrant and searched the office. Nothing of evidentiary value was located.

Detective Ramzauskas and Detective Martinez spoke with Greg Stasinos, Facility Director at the Colorado Department of Health and Environment. Greg was able to provide historical badge ID access information for Daniel from September 19, 2023, through December 14, 2023.

On December 15, 2023, Detective Pihlak updated search warrants for Daniel's cell phones, both his work and personal. Daniel's personal cell phone was determined to be a Samsung S23 Ultra with IMEI . The search warrants were signed by the Honorable Magistrate Russell to clarify date ranges that were inconsistent with Detective Coleman's previously issued warrants. Detective Waight took Daniel's cell phones as well as Kristil's to the United States Secret Service location to access advanced forensic software. Detective Waight completed the extraction of data from these devices and provided this data to Detective Pihlak.

On December 15, 2023, Detective Marshall arranged for to bring to Ralston House to participate in forensic interviews. Detective Marshall met with before the interviews. Detective Marshall explained that Detectives had learned that Jack Anthony Holland was not in the state at the time of Kristil's suspected murder. They expressed that they were skeptical that Jack was ever involved. Detective Marshall observed a forensic interview

On December 15, 2023, Detective Marshall contacted Kristil's father , and his wife by phone. During the conversation, advised the following: Kristil previously confided in that she and Daniel had marital problems . When was with Kirstil on Monday, December 11, 2023, Kristil told her that she had a photo on her phone of which she planned to use to seek full custody of the children.

On December 15, 2023, Detective King-Sullivan was the affiant on a search warrant for Daniel's vehicle. Detectives King-Sullivan and Trujillo served the search warrant. Inside Daniel's vehicle, they located a bag that contained his expired passport and a homeowners insurance policy for Daniel's second home on Davis St in Broomfield, CO. Additionally, the vehicle's dashcam was unplugged. Daniel's children said he was very consistent about maintaining.

On December 16, 2023, Detective Martinez spoke with Anthony Jack Holland on the phone. Anthony stated that he had spoken with local police and was aware of an investigation that involved Kristil. Anthony stated he has lived in Utah since February 2023. He lives with Sydney and Bradford Harper. On Wednesday, December 13, 2023, he was at work from 2:45 PM until 9:30 PM at Texas Roadhouse in Sandy, Utah. On December 14, 2023, he was with Sydney and Bradford, until the evening when they attended a concert. Police contacted him before the concert. Antony was cooperative and willing to participate in whatever was needed from law enforcement and provided all personal contact information.

Regarding, Jack Anthony Holland's location: the drive time from his verified address in Utah is an approximate 8-hour drive. Additionally, information was gathered from flight records, and Jack was not a known passenger on a commercial flight. Jack's vehicle was also recorded via license plate reader at 12:40 PM in Saratoga Springs, UT (an approximate 8-hour drive).

On December 16, 2023, Detective Ramazauskas received a call from [redacted] who wanted to voice some concerns regarding her son-in-law Daniel "Dan" Krug. [redacted] said she was fuzzy on her initial statement due to everything that was going on but she wanted to ensure she shared that Dan and Kristil were planning to get a divorce. She said Kristil wanted full custody of the children and initially had plans to wait on leaving Dan until [redacted] was out of school, but it appeared that she was no longer planning on waiting that length of time. [redacted] said Kristil began separating her and Dan's bank accounts and mentioned Dan wanted to take one of their children's educational funds. [redacted] said Kristil had moved her items from the master bedroom, into [redacted] room, and she and Dan hadn't been sleeping together for over a year. [redacted] described Dan and Kristil's relationship as not good.

[redacted] said she felt Dan "had motive" when he talked to her. She said she could not understand why Dan called her on the day of Kristil's death. [redacted] said Dan had never reached out to her before to check on Kristil. She further said if Dan was concerned he would typically call Kristil's brother, [redacted], or his wife, [redacted].

[redacted] said Dan told her and other family members that on the day of Kristil's death the cameras were off and there was tape covering them. It was [redacted] understanding Dan learned of this detail during his interview with Detectives. [redacted] said Kristil had the cameras installed in October and felt like Dan was "lackadaisical" with them.

[redacted] said since Kristil's death, Dan has spoken about selling his and Kristil's house, throwing her clothing away, that he did not want to go back to the house and did not want the kids to go back to the house. [redacted] said Dan felt as if he was being framed in the Murder of Kristil.

In total, more than 42 homes in proximity to 3132 Promontory Loop have been canvassed. All

known surveillance cameras have been collected or requested. There is no unknown person witnessed on the property of the 3132 Promontory Loop on December 14, 2023.

As of December 16, 2023, based on the totality of the investigation, the following timeline of events occurred on Thursday, December 14, 2023:

6:45 AM: Daniel's vehicle leaves the garage.

6:47 AM: Daniel returns inside of his garage.

7:42 AM: Kristil's vehicle leaves the garage.

7:58 AM: Kristil's vehicle returns inside the garage.

8:15 AM: The front door, side yard, and backdoor cameras go offline at the residence.

8:56 AM: A message from Kristil's phone to Daniel's phone, "Can you get ? I need to meet with Martinez."

9:17: A Message from Daniel's phone to Kristil's phone, "Sure thing. Fyi I forgot my Chicken on the counter. Please put it in the fridge"

9:27 AM: Daniel enters the main lobby of his work in Glendale, Colorado.

9:29 AM: Daniel accesses the elevator at his work.

9:29 AM: Daniel was seen via video surveillance on the fifth floor of his work, verified by Daniel's issued access card.

10:03 AM: A message from Daniel's phone to Kristil's phone, "Did you tell you were picking up early? Just need to know what time so I leave work."

9:45 AM: Daniel is viewed on camera surveillance wearing the same clothes when interacting with police later in the day.

10:33 AM: Daniel messaged Detective Martinez, "Hi Martinez, Kristil didn't say when you are meeting and I think her phone is off. Please have her text me the time to pick up . I'm headed into meetings."

11:47 AM: A message from Daniel's phone to Kristil's phone, "I'll plan on 30 minutes early if I don't hear otherwise. Text me."

11:59 AM: Daniel messaged Detective Martinez, "This feels weird." Daniel included a screenshot taken at 11:47 AM between his phone and Kristil's phone of unread messages he sent.

12:02 PM: Daniel called Broomfield Police non-emergency line to report a welfare check on Kristil.

12:09 PM: Daniel messages Detective Martinez that he reported the welfare check.

12:12 PM: Daniel messages Detective Martinez that he had called Linda, Kristil's mother to also check on Kristil.

12:23 PM: Stacy, a neighbor, attempts contact at 3132 Promontory Loop to check on Kristil.

12:24 AM: Officer O'Hayre arrives at the residence.

12:28 AM: Officer O'Hayre locates Kristil down in the garage, viewing through a garage door window.

12:43 AM: Kristil is pronounced deceased.

1:24 PM: The front door camera goes back online.

Based on the totality of circumstances, there is no supported evidence to believe Jack Anthony

Holland murdered Kristil, and was later verified to be in the State of Utah.

The last known person to see Kristil alive is Daniel Krug, her husband. The IP address used while stalking Kristil originates from Daniel's workplace. The only persons to have access to the residential cameras at the Krug home, to manually turn them offline are Daniel, Kristil, and . Kristil was said to be someone who would fight and defend herself and there is no sign of struggle at the residence. Kristil was also found to have possession of her loaded concealed carry firearm on her person; indicating she was taken by surprise or by someone familiar.

Based on the totality of circumstances, Probable Cause exists to believe that Daniel Krug committed the offense of Murder in the First Degree, CRS 18-3-102.

On December 16, 2023, Daniel Krug was taken into police custody at about 5:53 PM on the property of the King Soopers, 2355 W. 136th Ave, Broomfield, Colorado. Daniel invoked his right to an attorney before making any statements. Daniel was transported to the Broomfield County Detention Facility, where he was booked and lodged into the facility.
