- 1. Call to order 5:57 p.m.
- 2. Approval of January board minutes and general meeting minutes

- Book fair with Roundabout
 - o Got school and district approval, week of April 7, set up Monday, open Tuesday Thursday, Desiree will talk to admin about best hours to be open, open for lunch then keep open for families after school on Wednesday, will need volunteers to staff the fair, Roundabout working on book list for review, can set up e-wallets so families can put money in for their kids, families can also donate additional to benefit kids who can't afford books, discussed if we want to authorize a portion of money to go towards covering extra if a student is short a certain amount (set a cap), we get 15% of proceeds, Desiree to loop in Anthony, Val mentioned that Big Story is a sponsor so be prepared if they ask why we didn't do a book fair with them, admin asked us to have a plan for kids who can't afford a book (FAN), put together a communications plan (newsletter, on driveway announcement board, social, dedicated email from PTSO, get language arts teachers to send email out to families, poster for sandwich board with QR code for e-wallet)

 - o Spoke with Synergy Health who does chair massages but cost is \$1700, look into COCC massage school. Other ideas include lanyard, coffee cart, gift cards, breakfast burritos, smoothies, lunch, raffle prizes (need to start rounding up raffle items)

 - o Desiree to talk to admin about open dates, maybe late April
