What is the need of FSSAI License or Registration?

Section 31 of FSS Act 2006 states that –

- No person shall commence or carry on any food business except under a License/Registration.
- Premise based License/Registration of FBO Units
- Completely Online procedure for obtaining License/Registration



Food Business and Food Business Operators



Section 3 (n) of the FSS Act states that a "Food business"

- means any undertaking, whether for profit or not and whether public or private, carrying out any of the activities related to any stage of
 - Manufacture/processing, packaging,
 - storage, transportation, distribution of food,
 - import and
 - includes food services, catering services,
 - sale of food or food ingredients;

Section 3(o): "Food Business Operator" in relation to food business means a person by whom the business is carried on or owned and is responsible for ensuring the compliance of this Act, rules and regulations made thereunder;

Licensing and Registration of Food Business

All petty FBOs should register themselves with the registering Authority

License for carrying of Food business, which are not covered under schedule 1, should be granted by the concerned States/ UTs Licensing Authority



FBOs should ensure that all conditions of license as provided in Annexure-2 of Form B (Application for License/Renewal of Licence under FSS Act 2006) in schedule 2 and safety, sanitary and hygienic requirement provided in the schedule 4 contain under different parts are compiled with all the times

FSS (Licensing and Registration of Food Businesses) Regulations, 2011



Eligibility Criteria for grant of License/Registration

- Central License Fee of Rs. 7500 per year, Rs. 2000 per year (for Departmental Canteens)
- Central Registration Rs. 100 per year (only for Deptt Canteens)
- State License Annual fee of Rs. 5000, Rs. 3000 (For Manufacturers)
- State License Rs. 2000 per year
- State Registration Rs. 100 per year

Validity: FBO can choose from one to 5 years at one go.

FSSAI License/Registration number is of 14 digits with following pattern for differentiate between the three categories:

License – 1xxxxxxxxxxxxxxx

Registration – 2xxxxxxxxxxxxxx, RC carrying photo of FBO.

- Importer/Exporter of Food
- E-Commerce FBOs
- Head Offices
- Proprietary Foods
- Non-Specified Foods
- Nutraceuticals
- Radiation Processing of Foods
- Premises located at Central Govt Establishments.
- FBOs located at Railway Stations, Airports or Seaports.

Non-requirement of FSSAI Registrations



Following categories of FBOs have been kept out of the list of FSSAI Registration subject to adherence of conditions by parent entities-

- Producer of milk who is a registered member of a dairy Cooperative Society registered under Cooperative Societies Act and supplies the entire milk to the Society
- Last mile delivery Persons
- Direct Sellers
- Food Carts/Vendors of a food chain
- Vending Machines/Food ATMs


A 17 digit Reference Number is the User Id generated for future login.

Food Product Category

Renewal of License/Registration



- Window for Renewal of License/Registration made available to FBOs as early as 180 days prior to expiry date
- If an FBO doesn't apply for renewal till 30 days prior to expiry of License (not in case of Registration), he/she is required to submit a late fee of Rs. 100 per day till the last date of expiry. (i.e max of Rs. 3000 as late fee)
- Food Businesses can now renew their License/Registration even after the expiry date till 180th day with payment of penalty.

Modifications, Expansion or Changes in premise(s) after grant of license or registration



FBO shall intimate any modifications or additions or changes in product category, layout, expansion, closure, or any other material information based on which the license was granted and such information shall be conveyed before the changes occur.

Return – Form D1 and D2

- Every Manufacturer and Importer has to file his annual return according to Form D1 by 31st May of each year. (Mandatory online Returns wef FY 2020-21)
- Milk/ Milk product manufacturers have to **file Form D2 twice a year** i.e. 1^{st} Apr 30^{th} Sep and 1^{st} Oct 31^{st} Mar, within one month of completion of respective period.
- Any delay in filing return beyond 31st May of each year shall attract a penalty of Rs 100 per day of delay
- Quarterly return by exporters.



Responsible persons at Food Units



- 1. Authorised Signatory/ Proprietor for applying License
- 2. Technical Person incharge of Operation having degree as prescribed in Condition of License.
- 3. Person responsible for Complying with Condition of License Nomination to be filed in Form IX of FSS Rules. He is responsible for any type of communication with Licensing Authorities.

He is the nodal person for the FBO to handle Consumer Grievances, until or unless FBO designates any other person for this purpose.

Any change in the nominations shall be conveyed to Licensing Authority.



Condition of License



- Display true copy of License.
- Give necessary access to Licensing Authorities to the premises.
- Inform authorities about any change or modification of activities.
- Employ atleast one technical person having prescribed qualification or Food Safety Supervisors.
- Furnish periodic Annual Return (Form D-1).
- No product other than indicated in License shall be produced.
- Maintain Factory's Sanitary and Hygienic standards. Also Workers'
 hygiene and health check-up as prescribed in Schedule-4 to be done
 on regular intervals.
- Maintain daily records of production, raw materials utilizations and sales etc.



Condition of License



- Source and standard of raw material used is of optimum quality
- Testing of relevant chemical and /or microbiological contaminants of food products in accordance with these regulations (Apr-Sep, Oct-March with at least three months gap)
- Required temperature shall be maintained throughout the supply chain
- Manufacturer/Importer/Distributor shall buy or sell food products only from, or to Licensed/Registered Vendors and should maintain record thereof
- Hotels/Restaurant and other food stalls shall put up a notice board containing separate lists of articles which have been cooked in ghee, edible oil, vanaspati & other fats for information to purchaser



Streamlining the process of issuance of Lic/Registration



Timelines for issuance of Lic/Reg as prescribed in the Regulation are being scrupulously followed.

In this regard, FSSAI has issued following orders:

- i. Exempting pre-License inspections
- ii.Online dispatch of QR code embedded Licenses/Registrations to FBOs.
- iii.Issuance of License/Registration in case of unattended applications.
- iv. Quicker processing of license Applications for Manufacturing KoB

Allowing Modification of License with retaining the same license number –

- Change of Category between State to Centre or vice versa
- Change of Premise

Endorsements in License/Registration

- Organic Food Endorsement for using Jaivik Bharat logo
- Fortified Food Endorsement for using +F logo

- Simpler interfaces and interactive pages

- FBO Help to lodge ticket for technical issues.

- Sweets and Namkeen Order / Fruits and Vegetables Order
- Nutraceutical under CL only
- Building FBO's Online History Digitization of all Compliances
- Mandatory display of License/Reg no on invoices.



Proposal for Amendment in Draft FSS (Licensing and Registration of Food Businesses) Regulations, 2021



- New Definitions proposed for
- ✓ Brand Franchiser/ Owner,
- ✓ Digital and electronic network and E-Commerce
- ✓ Direct selling entity and Direct Sellers
- ✓ Food Handlers and Food Safety Supervisor,
- ✓ Relabeller and Repacker
- Definition of Petty Food Manufacturer is proposed to be revised and curtailed, for accommodating in Schedule 1.
- Provision for mandatorily Submission of Annual Declaration for Petty FBO, failing which suspension or cancelation of Registration certification.
- Exemption of petty FBOs from taking Registration in case parent entity takes responsibility



Continued...



- Perpetual License and Registration subject to submission of Annual Return (Food Safety Compliance Return) and Declaration.
- Centralized license for State/Central Govt. Institutions having presence in different part of States or the country.
- Annual Return (Food Safety Compliance Return) has been made mandatory for every license Holder and the penalty of Rs. 100 per day for delay that can be levied and shall not exceed 5 times the annual fees.
- Enabling clause for
 - Scheme of Testing,
 - Inspection and Audit,
 - Hygiene Ratings,
 - Food Safety Supervisor & Facilitators (Food Safety Mitra)
