## **TERMS AND CONDITIONS**

- No money on any pretext except allowed by Govt. shall be collected by the vendor/ operators
  against the Aadhaar enrolment and violation of this terms and condition will invite stern
  action as per law and cancellation of engagement order immediately.
- The hire rate will be calculated from the date of start of enrolment. They are directed to start enrolment within three to five days from the issue of this order without fail by observing all Govt, formalities.
- All the terms and conditions made by the Govt. in the agreement with existing vendor will be applicable to all of them.
- Maintenance of social distance, wearing of masks and etc. shall be followed strictly as per the COVID-19 protocol issued by the Govt. from time to time.
- 5. Any violation of terms and conditions will result in the cancellation of this work order.
