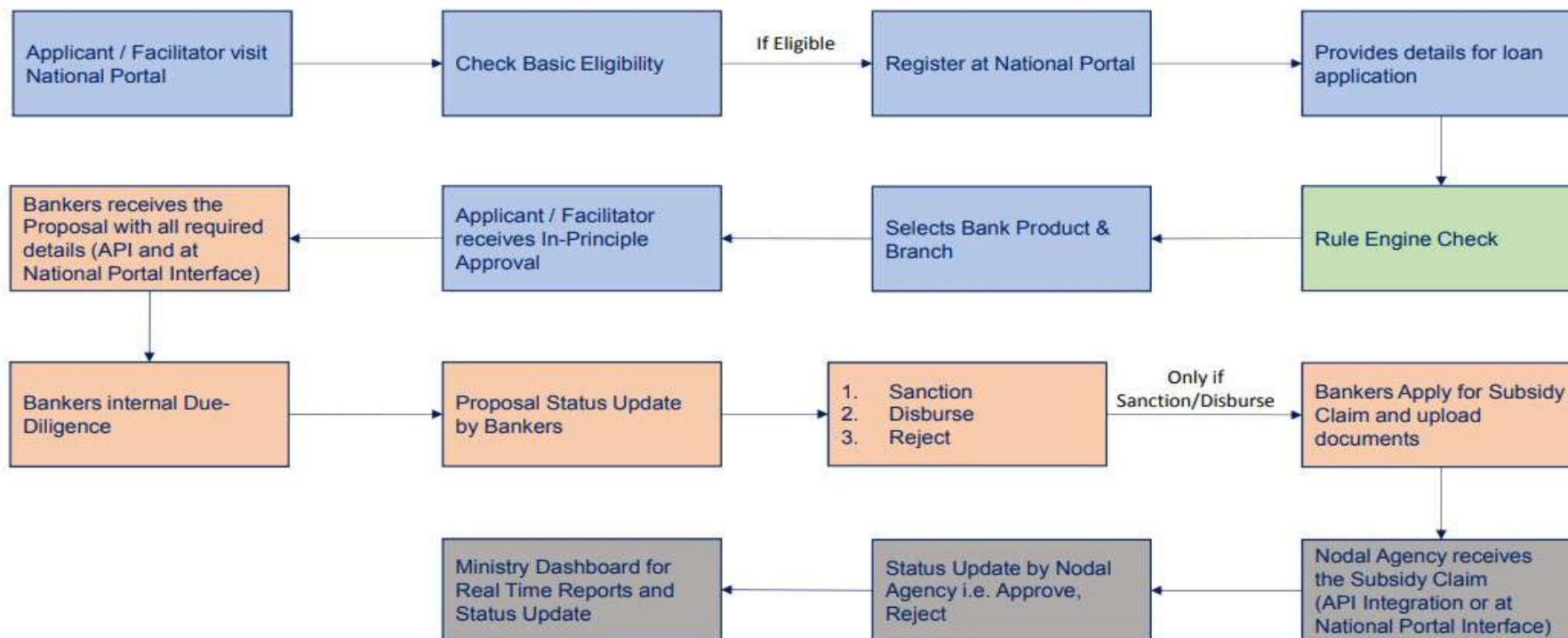

Introduction

1. Agri-Clinics and Agri-Business Centres Scheme (ACABC) is being implemented by the Ministry of Agriculture and Farmers' Welfare, Government of India, in association with NABARD & MANAGE.
2. The objectives of the scheme are to supplement efforts of public extension, support agriculture development and to create gainful self-employment opportunities to unemployed agricultural graduates, etc.
3. Agri-Clinics: Agri-Clinics provide expert advice and services to farmers for soil health, cropping practices, plant protection, crop insurance, post-harvest technologies, as well as offers clinical services for animals, feed and fodder management, prices of various crops in the market, etc.
4. Agri-Business Centers: Agri-Business Centers are units of Agri-ventures established by unemployed trained agriculture professionals, including maintenance and custom hiring of farm equipment, sale of inputs and other services in agriculture and allied areas.
5. 44 % of project cost will be as composite subsidy for women, SC/ST & all categories of candidates from NE and Hill states and 36% of project cost for all others.

Eligible Applicants

1. Only candidates who have completed training through MANAGE will be eligible for loan/subsidy.
2. Retired Officials are not eligible for subsidy under the scheme, however, those who undergo training provided they establish ventures by self-financing and not eligible for subsidy.
