 - iii. The board requested minor alterations that would add the newly appointed City Manager of Gonzales, Carmen Gil, as a signatory.
 - iv. Legal Counsel representative, Shannon L. Chaffin, recommended moving the item to the Regular Agenda for the board to adopt the resolution properly.
 - 1. Following this directive, President of the Board, Chris Lopez, requested a motion to make item 7a part of the Regular Agenda.

- v. No public input was provided after the approved changes to item 7a to the Regular Agenda. President Lopez called for a motion to approve the resolution following the minor change to add City Manager Carmen Gill as a bank signatory.

 - i. TAMC will be more engaged in broadband efforts throughout Monterey County.
 - ii. Over the past year, TAMC Board identified broadband as critical infrastructure that is critical to transportation projects.
 - iii. Mayor LeBarre concluded with a notice to the board regarding their involvement and the potential need to present their work to assist TAMC's information and data collection on all of the broadband projects in the area.
- b. President Lopez's Report was concerning two timely items:
 - i. The BEAD Digital Equity Regional Workshop on June 02, 2023, at CSU Monterey Bay, which MBEP co-hosted.
 - 1. Lopez cited that the workshop's mission was centered on bridging the digital divide and part of the state's efforts to collect public feedback on the future of digital equity and the use of the upcoming BEAD funding.
 - Lopez also highlighted that the event was well-attended and succeeded in bringing the region together to produce unique strategies for state officials to collect.
 - Councilmember Chavez followed up and noted that the diversity in the local community voices present at the event and who had spoken to share their input was vital.
 - ii. The recent release of Governor Newsom's Revised Budget for the State of California, as of May 2023. Notable items mentioned by President Lopez include:
 - 1. A deficit in the state's budget was cited to be approximately \$30 Billion.
 - 2. The state's deficit could cause shifts in the allocation of broadband funds and potentially delay the state's initial timelines in the digital equity space.
 - iii. President Lopez requested an update on the Golden State Net Authority in the upcoming SSVBA Regular Meeting scheduled for July 20, 2023.
- c. Board Member Untalon shared an announcement regarding her immediate resignation to the board and public from her role at the City of Greenfield as soon as her replacement is successfully appointed.

SUMMARY

An update on the Golden State Connect Authority (GSCA) program of work within the South Salinas Valley Broadband Authority area will be presented.

BACKGROUND

Local Agency Technical Assistance Program

The CPUC Local Agency Technical Assistance (LATA) Program provides up to \$500,000 per eligible applicant (cities, counties, and other local agencies) to fund 100% of pre-broadband deployment activities. All five members of the South Salinas Valley Broadband Authority (SSVBA) applied for and were awarded LATA funds in partnership with GSCA, specifically for completion of network designs.

All GSCA-partner LATA awardees from SSVBA have moved through the first and second of three phases of design, Conceptual Design and Refined High Level Design, under the scope of work outlined in their LATA awards. Conceptual Design involves the development of network design maps for the entire jurisdiction, validating and mapping addresses from the awardee and the CPUC & FCC, development of an initial Bill of Materials and build cost projections. High Level Design includes a more refined package of design materials and a more accurate budget. All the city members of SSVBA will receive low-level, construction-ready network designs for their entire jurisdiction. Unincorporated Monterey County will receive low-level, construction-ready network designs for slightly over forty miles under their LATA grant. The low-level design project area to be pursued within Monterey County under the LATA grant will be determined in partnership with County representatives with recommendations from GSCA.

Low-level network designs will begin in the next few weeks for the SSVBA member cities. It is anticipated that low-level network design for unincorporated Monterey County under the LATA grant will begin in late August/early September.

CPUC Federal Fund Account/Last Mile Grant Program

The CPUC Federal Fund Account (FFA)/Last grant program application window officially opened on Friday, June 30th, and will remain open for 90 days, closing at the end of September 2023. FFA/Last Mile program monies will fund deployment of broadband

infrastructure across California, with a focus on unserved/underserved areas, as delineated on the CPUC FFA/Last Mile program map. Eligible applicants for this program include providers and network administrators.

These program dollars, such that they are available for areas within the SSVBA member region, will be part of the financial stack anticipated to be used by GSCA to an deploy open access municipal broadband network across the SSVBA region.

Statewide Planning for Federal Broadband Investment

Within the federal Infrastructure Investment and Jobs Act (IIJA), \$65 billion was allocated for broadband investment. The monies were allocated to the National Telecommunications and Information Agency, an Executive Branch agency located within the US Department of Commerce, specifically for the Broadband Equity, Access, and Deployment (BEAD) Program.

The money within the BEAD Program has been divided into various programs focusing on broadband deployment and digital equity and will be allocated to states for inclusion in the implementation of state broadband plans. To access these federal dollars, states must first complete a comprehensive planning process that results in both a state broadband deployment plan and a state digital equity plan.

The state of California has applied for and received their planning allocation and has begun the required, robust planning process for both the broadband deployment state plan, led by the CPUC, and the digital equity state plan, led by the California Department of Technology. Twenty Broadband for All Digital Equity and BEAD Planning Workshops took place in regions across the state during the months of April, May, and June. The feedback from these workshops will be incorporated into the state plan and will influence how future federal dollars that California receives under the BEAD program will be allocated. Similarly, responses to a statewide survey created by the California Department of Technology and distributed to each RCRC member county with a request to distribute across member communities to maximize participation, will also influence how the Digital Equity Plan developed by the state will delineate distribution of these dollars.

Under the BEAD program, \$42.5 billion was allocated to states for broadband deployment, and \$2.75 billion will be allocated for digital equity. On Monday, June 26th, the US Department of Commerce announced the allocations for each state, territory, and the District of Columbia. California received the second highest allocation, behind Texas, of \$1.86 billion. These dollars will be distributed to states once state plans (referenced above) have been completed and submitted to NTIA for review and acceptance.

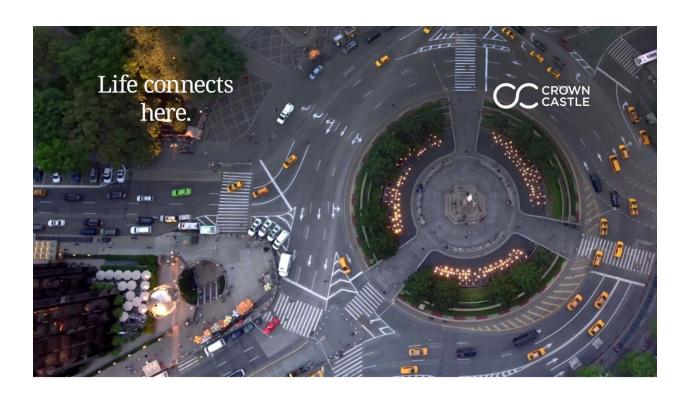

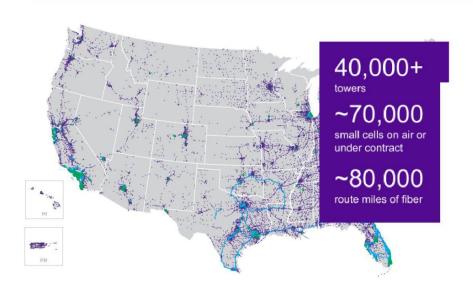

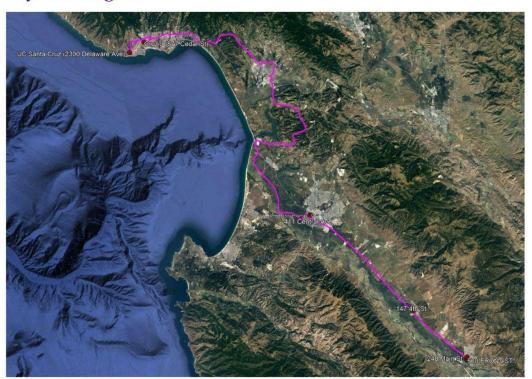

RESOLUTION NO. 2023-03

A RESOLUTION OF THE SOUTH SALINAS VALLEY BROADBAND AUTHORITY AUTHORIZING THE USE OF ELECTRONIC SIGNATURE FOR CONDUCT OF BUSINESS

WHEREAS, the Board of Directors ("Board") desires to establish standards for when electronic signatures may replace hand-written or wet signatures on South Salinas Valley Broadband Authority ("Authority") documents, thereby encouraging the use of paperless, electronic documents when appropriate and allowed by law.

WHEREAS, the term, "electronic signature," is defined as data in electronic form that is attached to or associated with other data in electronic form in order to be used by the signatory to sign. Thus, providing any electronic form of a signatory's original signature on an electronic document may constitute an electronic signature.

WHEREAS, for the purposes of this resolution, an electronic signature is not required to be subject to a digital certificate issued by a licensed certificate authority for providing authentication of signed electronic documents unless otherwise noted, and may also include scanned, faxed, or emailed copies of signatures.

WHEREAS, use of an electronic signature provides an efficient and secure way of signing electronic documents, increasing productivity by facilitating the proper use of electronic records and electronic signature technology to collect and preserve signatures on documents in a timely manner while preserving the security and integrity of documents, and the Board desires to establish policies for use of the same.

NOW, THEREFORE, the Board of the South Salinas Valley Broadband Authority resolves as follows:

- 1. All Board members and official signatories of the South Salinas Valley Broadband Authority have the option, but are not required, to provide an electronic version of their original signature on electronic documents pertaining to all matters associated with the South Salinas Valley Broadband Authority consistent with the requirements of this resolution.
- 2. This resolution broadly permits the use of electronic signatures, but there are some circumstances in which electronic signatures cannot be used, or only electronic signatures with a digital certificate may be used. Subject to State and federal law as may be amended, the Board authorizes use of an electronic signature consistent with the following:

Document Type Examples	Electronic Signature Acceptable?	Notes
Memos, Forms, Letters, and other Correspondence	Yes	Electronic signature is recommended.
Contracts	Yes	Electronic signature is recommended if acceptable to the other parties to the contract. Contracts involving an interest in land must be a "wet" signature or may be signed with a digital certificate.
Certificates, Permits	Yes, if allowed by law	General Counsel to determine whether applicable laws permit an electronic signature to be used on a case-by-case basis.
Documents Requiring Notarization	No	All signatures must be "wet" signatures.
Resolutions	Yes	Manual "wet" signatures or electronic signatures are acceptable.
Transactions requiring a handwritten signature, or for which an electronic signature is not enforceable by law	No	Consult General Counsel as to applicable laws for such transactions.
Checks or any other forms of payment issued by OCCOG	Yes	Electronic signature is permitted if otherwise allowed by the financial institution; however, General Counsel is to determine where applicable laws prohibit an electronic signature from being used.
Use of an electronic signature by another	No	Email forwarding of an electronic signature for the use by another is not authorized.

Proxy Signatures	No	Note: The Vice President may sign in
		the absence or unavailability of the
		President. Such a signature is not a
		"proxy" as it is signed in the Vice
		President's official capacity.

In cases of doubt or where clarity is needed, it is recommended to seek General Counsel's advice to determine if applicable laws permit an electronic signature to be used.

- 3. Whenever an electronic signature is authorized as noted in Section 2, above, the use of an electronic signature is permitted if the digital signature meets all of the following criteria:
 - a. It is unique to the person using it.
 - b. It is capable of verification.
 - c. It is under the control of the person utilizing it.
 - d. It conforms to all criteria set forth in this resolution.
- 4. In the case of communications, contracts, or transactions which must be signed by outside parties not part of the Authority, each party to the agreement must agree in advance to the use of electronic records and electronic signatures unless otherwise required by law. Such consent may be withdrawn by any party at any time such that future documents requiring a signature must be manually signed.
- 5. When a document is electronically signed, the official representative of the South Salinas Valley Broadband Authority should, upon receiving the request, provide a copy of the electronically-signed document to the other parties in an electronic format that is capable of being retained and printed by the other parties.
- 6. The official representative of the South Salinas Valley Broadband Authority is responsible for the physical and/or electronic storage of all signed documents. All electronic records and electronic signatures shall be capable of retention and accurate reproduction by all parties or persons entitled to retain the records, transactions, or other documents upon submitting a request to the official representative of the South Salinas Valley Broadband Authority.
- 7. The South Salinas Valley Broadband Authority board members, staff, and official representatives are responsible for determining acceptable electronic signature methodology and technology consistent with this resolution, along with current state legal requirements and industry best practices, ensuring the security and integrity of the data produced and collected from the South Salinas Valley Broadband Authority.

- 8. Any use, execution, acceptance, or modification of an electronic signature or associated electronic record by any person in a manner that is unauthorized or not in compliance with applicable law or this resolution shall render such signature or record invalid. Any unauthorized signing of any contract, record, or other document, shall render such contract, record, or other document invalid as not fully and properly executed by the South Salinas Valley Broadband Authority.
 - 9. This resolution shall take effect immediately.
