## Statement

This Student Behaviour Code of Conduct outlines the positive behaviour April Well Limited expects from students. It also provides information about specific laws in the UK. The aim is to provide clear guidance in key areas of April Well Limited's expectations. The guidance is written for the benefit of students, parents/agents and staff.

April Well Limited is a small guardianship organisation. Students supported by April Well normally live in boarding accommodation at their schools or with their parents. April Well Limited does not currently arrange homestay accommodation or place students with host families.

## Behaviour and conduct while in the care of April Well Limited

When you are studying in the UK and supported by April Well Limited, your behaviour should be safe, respectful and responsible at all times. This includes when you are:

- living in school boarding accommodation;
- staying with your parents or another responsible adult;
- travelling to or from the UK; and
- taking part in any activities or trips linked to your education.

April Well Limited expects all students to:

- be polite and courteous to others, including school staff, April Well Limited staff, parents, agents and other students;
- follow the rules and behaviour code of your school as well as this Student Behaviour Code of Conduct;
- follow the reasonable instructions of adults who are responsible for your care and safety (for example, school staff, house parents, your parents and April Well Limited staff);
- respect other people's culture, background, religion and beliefs;
- treat other people's property with respect and not cause damage to property or the environment;
- use appropriate language and avoid swearing, rude or abusive comments;
- not bully, harass or discriminate against anyone, whether in person or online;
- use mobile phones, social media and other digital devices responsibly, in line with school rules and April Well Limited's Online Safety Policy;
- tell a trusted adult (for example, a member of school staff, your parents or April Well Limited) if you are worried about your own safety or the safety of someone else;
- follow the laws of the UK, including those set out below.

## **Laws regarding the consumption of alcohol**

April Well Limited does not permit students to consume alcohol whilst under our care. In the UK it is illegal for people under 18 to buy alcohol in a pub, off-licence, shop or elsewhere. In most cases, it is against the law for anyone to buy alcohol for someone under 18 to drink in a pub or a public place. Being drunk in a public place can also lead to police involvement or disciplinary action by your school.

## **Laws regarding the use of drugs and illegal substances**

April Well Limited prohibits students from using recreational drugs and illegal substances whilst in our care. In the UK you can get a fine or prison sentence if you:

- take drugs;
- carry drugs;
- make drugs; or
- sell, deal or share drugs (also called 'supplying' them).

If you are under 18, the police are allowed to tell your parent, guardian or carer that you have been caught with drugs. April Well Limited and your school will also treat drug use very seriously, and this may result in serious disciplinary action, including exclusion or termination of guardianship.

## **Laws regarding smoking and vaping**

April Well Limited prohibits students from smoking and vaping whilst in our care. In the UK, it is illegal to buy cigarettes or vapes (e-cigarettes) if you are under the age of 18. Many schools also have strict rules about smoking and vaping anywhere on or near school premises. Breaching these rules may result in sanctions from your school and from April Well Limited.

## **Laws regarding sexual activity**

April Well Limited prohibits students from engaging in sexual activity whilst in our care, even if they are over the age of consent. In the UK the age of consent is 16. That means that it is illegal to have sex with someone under the age of 16. It is also a criminal offence for any adult in a position of trust (for example, a teacher or other professional working with children) to have a sexual relationship with a student under 18.

## **Students must not:**

- engage in sexual activity or intimate behaviour with another person whilst under the care of April Well Limited;
- share or request nude or semi-nude images of themselves or others; or

- behave in a sexually inappropriate or sexually harassing way towards others, whether in person or online.

Any concerns about sexual activity or inappropriate sexual behaviour may be treated as a safeguarding concern and will be dealt with in line with our Safeguarding and Child Protection Policy.

## **Laws regarding tattoos and body piercings**

April Well Limited prohibits students from having a tattoo or body piercing whilst in our care. In the UK, it is illegal to tattoo a young person under the age of 18, even if they have parental consent. There is no legal age of consent for body piercing, and so it is legal for someone under the age of 18 to have a piercing as long as they have consented to it. Children under the age of 16 cannot legally consent to a genital (or in the case of girls, nipple) piercing, as this is considered to be indecent assault.

Students must not arrange for tattoos or body piercings, including during time away from school, at weekends or during school holidays, while they are under the care of April Well Limited.

## **Arrangements when students wish to stay away overnight**

While you are under the care of April Well Limited, you are not allowed to stay overnight away from your usual accommodation (for example, your school boarding house or your parents' home) unless permission has been given by your parents and your school, and April Well Limited has been informed in advance.

If you wish to stay overnight away from your usual accommodation (for example, at a friend's house or with a family friend), you must:

- ask your parents for permission and make sure they are happy with where you will be staying and who will be responsible for you;
- ask your school for permission, if you are in boarding accommodation, and follow the school's procedures;
- provide April Well Limited with full details in advance, including the address, dates, contact details of the responsible adult and confirmation that your parents and school agree to the arrangement.

April Well Limited will only agree to such arrangements where we are satisfied that there is a responsible adult present and that the arrangement is safe and appropriate. April Well Limited does not arrange homestay or private fostering accommodation.

If you stay away overnight without proper permission or without informing April Well Limited, your parents and school may be very worried about your safety and you may be treated as a missing student. This may result in disciplinary action by your school and by April Well Limited.
