# Approve Minutes from January 3, 2023 Meeting:

# 2023 Lions Club Request:

# 2023 Salary Ordinance:

  - Administrative Assistant/Maintenance Personnel: \$35,000/year

### 2022 Annual Financial Report:

Jami Pratt presented the 2022 Annual Financial Report. She stated that a few line items
were negative because we spent a lot more than budgeted for Township Assistance.
SBOA stated that it was not a worry as we would recoup that money from our deposits in
2023. Zack Light made a motion to approve the 2022 AFR. Stephanie Cooper seconds.
Motion approved unanimously, 3-0.

### **Parks Department Request:**

 Jami Pratt presented the Board with a request from the Frankfort Parks department asking for \$3,000 to help with adaptive equipment for the park.
