

## **CENTER TOWNSHIP BOARD MEETING MINUTES**

**06/01/2021**

Called to order at 12:04 pm in the Conference Room at the Center Township Trustee's Office.

### **Approve Minutes from May 3, 2021 Meeting:**

- Jami Pratt presented the minutes from the May 3, 2021 meeting for approval. Zack Light made a motion to approve the minutes. Jada Ray seconds. Motion approved unanimously, 3-0.

### **Community Services Agreement with the Frankfort Fire Department**

- Jami Pratt presented the Board with the prepared Community Services Agreement with the Frankfort Fire Department. It states that we are giving \$10,000 to the FFD for the training facility. Don Stock made a motion to approve this CSA. Jada Ray seconds. Motion approved unanimously, 3-0.

### **Haunted House at Parkview:**

- Jami Pratt was approached by Jennifer Davis of 7 Lights of Trepidation about the township paying for insurance for the haunted house again at the county home. Former Trustee Kevin Evans did this in 2019. Jami stated that she thinks it will be well attended this year especially since we are coming out of the pandemic. Insurance in 2019 was roughly \$1,127 and the township has the funds for it in the Community Events. Zack Light made a motion to approve paying up to \$1,500 for the insurance for this event. Don Stock seconds. Motion approved unanimously, 3-0.

### **Amended Salary Resolution/First Deputy Position:**

- Jami Pratt asked the Board to approve a pay raise for Alexis Marcum and the amended Salary Resolution for her raise. She is currently the Investigator but Jami would also like to make her the First Deputy. This pay raise would be for \$2,500 and that would take her up to \$38,000 a year. Jada Ray made a motion to approve the pay raise and the amended Salary Resolution. Zack Light seconds. Motion approved unanimously, 3-0.

### **Preschool Classrooms:**

- Jami Pratt presented the Board with a proposal for two new Preschool classrooms for CSF. She stated that the cost for the two is roughly \$144,000. Center Township has applied for a grant with the Community Foundation of Clinton County for \$25,000 for the technology portion of this. United Way has roughly \$23,000 available as of the last time Jami spoke with Anita Stewart. There is a waiting list and the two classrooms would be very useful for Center Township residents. Jada Ray made a motion to give \$10,000 towards the classrooms if we are awarded the grant through the Community Foundation. Zack Light seconds. Motion approved unanimously, 3-0.
