or display for sale or sell any good, with or without a Government trademark, in a manner that falsely suggest
it is Indian produced, an Indian product, or the product of a particular Indian or Indian tribe arts and crafts
organization, resident within the United States. Penalties under 18 U.S. Code § 1159 range from fines of
\$25,000 to \$1 million and/or imprisonment of 1 year to 15 years (initials)
Handcrafted items other than genuine Native American Arts and Crafts are permitted. NO COMMERCIAL ART
AND CRAFTS OR COMMERCIAL COMPANIES ALLOWED (initials)
