If you are displaying items as genuine Native American Arts and Crafts, you should have a certification as a Native Artisan. **Please display your certification at your booth and attach a copy of your certification to the application.** _____ (initials)

18 U.S. Code § 1159 – Misrepresentation of Indian produced goods and products states it is unlawful to offer or display for sale or sell any good, with or without a Government trademark, in a manner that falsely suggests it is Indian produced, an Indian product, or the product of a particular Indian or Indian tribe arts and crafts organization, resident within the United States. Penalties under 18 U.S. Code § 1159 range from fines of \$25,000 to \$1 million and/or imprisonment of 1 year to 15 years. _____ (initials)

Handcrafted items other than genuine Native American Arts and Crafts are permitted. **NO COMMERCIAL ARTS AND CRAFTS OR COMMERCIAL COMPANIES ALLOWED.** _____ (initials)

The sale of any beverages (carbonated, canned, bottled, fountain, water, etc.) are prohibited in vendor booths. _____ (initials)

Vendors are responsible for collecting any taxes on items sold. _____ (initials)

Vendors are responsible for cleaning their booth spaces and disposing of any trash before leaving the premises. The \$25 deposit per booth space will be refunded within one (1) week of the event once each booth space has been cleaned, all trash deposited in trash bins, and no damages are observed. Please take pictures of your space before set up and after tear down. _____ (initials)
