1. Call to Order

The meeting was called to order by President John Bosso at 6:58 pm.

2. MEMBER GENERAL COMMENTS

Josh Young raised the issue of plants obscuring visibility near the corner of Stone's Throw and Little Brush Ridge. Bill Hodge agreed to contact the homeowner.

Debbie Crittendon inquired as to whether a vote of the GRHA Board was required for her to build a metal shed 50 feet from her property line. The Board agreed that a vote was unnecessary if the structure was 50 feet from the property line but an El Dorado County permit would be required for a structure larger than 12 feet by 10 feet.

Rich Braun expressed continued concern over an adjacent property with an overgrowth of weeds and an apparently abandoned vehicle. Jason Bontrager suggested the Brauns and the Millers contact El Dorado County about the weed problem.

3. BOARD MEMBER and LEGAL AFFAIRS COMMITTEE CHAIRMAN GENERAL COMMENTS

The Board discussed a recent e-mail from a homeowner about suspicious vehicles parking in his driveway off Little Brush Ridge. The homeowner suggested the vehicles might be trying to reach the casino which is inaccessible from our neighborhood. The Board discussed the potential for moving a camera onto the neighborhood entrance by the mail boxes to monitor vehicles entering the neighborhood. An entrance sign saying "No Outlet" was also discussed.

Ryan Norton submitted information that GRHA presently has \$101,854.89 in its Checking/Savings Fund, and \$47,316.21 in its Reserve Fund, for a total of \$149,171.20 in current assets.
