MINUTES

1. Call to Order

DISCUSSION ITEMS

4. Treasurer Report

Ryan Norton reported that GRHA presently has \$22,302.72 in its Legal Fund, \$31,735.18 in its Operating Fund, and \$24,846.37 in its Reserve Fund, for a total of \$78,884.27 in current assets. In addition, GRHA also has \$4,260.00 in Accounts Receivable, making total assets of \$88,244.27. Total liabilities and equity amount to an equivalent sum.

5. Road Committee Report

Ken Lee stated that the remaining slurry seal work on the GRHA streets was scheduled to be completed on Friday, September 30. Several homeowners have agreed to volunteer on the Friday. He also noted that certain Little Brush Ridge drainage work was completed.

6. Status of Historical Document Scanning

Peter Abplanelp asked the Board to take custody of Homeowners Association records that have been stored in his barn. Ryan Norton and Eric Holm agreed to split the boxes and store them while work proceeds on digitizing the records.

7. Debris in front of homes

Board discussed the Sanders home at 5401 Reservation Road rented by Misty Smith where a significant amount of debris had accumulated. Eric noted cleanup had taken place and the Board discussed additional options to help the tenant remove debris. Eric offered to contact other homeowners if similar situations arise.

Eric moved approval and Jeff seconded. The Board approved \$100 to Alan Ruth for tractor work.

Eric discussed the requirements for conducting the annual meeting of the Association General Membership. The Board agreed to set the annual meeting for May 6 at the Placerville County Library Community Meeting Room 345 Fair Lane in Placerville from 9 a.m. to Noon.

The Board accepted Jeff Erskine's resignation and wished him well on his move out of state.

14. Authorize \$2,479 for 2023 Association D & O Insurance. Motion approved.
