### 4. Treasurer Report

Ryan Norton submitted information that GRHA presently has \$22,311.28 in its Legal Fund, \$75,310.61 in its Operating Fund, and \$24,855.93 in its Reserve Fund, for a total of \$122,477.82 in current assets.

# 5. Road Committee Report

Eric reported that resident Gayle Littrell told him she had someone who inspects bridges for their occupation inspect the GRHA bridge over Slate Creek on Reservation Road. He told her he thought the bridge was in relatively good shape and could be reinforced by streel plates that would extend its life and avoid costlier repairs or rebuilding.
