4. Approve Board Meeting Minutes – Jack Martin

5. Discuss and Approve the Date of the GRHA Annual Meeting - Board

Vivian A. conveyed the three possible Saturday dates and times the Placerville branch of the El Dorado County Library has its meeting room available for the annual meeting – April 9th 9:30am to 11:30am, April 16th 1:30pm to 3:30pm and April 30th 2:00pm to 4:00pm.

Vivian A. explained that with an April 9th date for the Annual Meeting, the Notice of Elections would be posted on Tuesday February 9, 2016, nominations for President and Secretary would be due on February 24, 2016 and the ballots would be mailed on March 10, 2016.

Vivian A. proposed April 9th from 9:30am to 11:30am citing having the meeting in the morning is less disruptive to the day than having a meeting in the afternoon. Board members agreed.

6. Discuss/Approve/Appoint the Nominating Committee - Board

11. Downed Tree on Turkey Track Road - Board

Jack M. explained this item. Michael A. indicated the tree fell across the roadway on December 23, 2015 and disrupted water service to several property owners. Jack M. conveyed that the Board had to make an emergency decision to have a tree company remove the root ball and tree that was blocking the roadway at the expense of \$1,785.00.

Jack M. asked Amber P. if they would have an issue if neighbors came on their property to take the wood from the tree. Amber P. will check with her husband, Nathan, to see if he is okay with people coming on property.

Peter A. conveyed that there is another dead tree in the same median where the fallen tree once stood and that should also be removed. Peter A. suggested having the El Dorado Irrigation District fix where the meters are and as part of road maintenance on Turkey Track Road, straighten out the road and eliminate the tree area that both sides of the road go around.

Jack M. requested that the Roads Committee meet and clarify the property boundary lines and to take a look at the dead tree Peter A. mentioned to determine if it needs to be removed.

Dick N. asked if the fallen tree would be covered by the property owner's insurance company instead of the GRHA absorbing the expense of the tree service.

12. Request for Variance of 50' Setback by Property Owner- Board

Jack M. identified the property owner that has made this request. Jack M. explained the type of building the property owners wants within the 50' setback and that he sent an email to the property owner as to what is required (site plans, picture of building, etc.) before the Board can discuss and vote.

Jack M. conveyed that he did not receive a reply from the property owner and the property owner did not attend this Board meeting.

Jack M. conveyed that this item it tabled at this point.

13. Possible relocation of gate from entrance of Grassy Run Road to end of Reservation Road at Rancheria - Board

Jack M. explained this item of moving the gate from the Grassy Run Road entrance and K-rails would be erected at the end of Reservation Road at the Rancheria border.

Michael A. received an estimate from Wade Ehrlich & Company that would supply the K-rails.

Jack M. requested that the Roads Committee get estimates for labor and materials. Michael A. conveyed he will need to contact the company supplying the K-rails for an estimate.

14. Treasurer Update - Peter Abplanalp

Peter A. conveyed his appreciation to the property owners that have paid the first installment of the 2016 annual dues.
