Peter A. announced the new owners of 5176 Little Brush Ridge Road, Brian and Lisa Cord. Peter A. also announced that the vacant lot on Grassy Run Road was sold and that the new owners provided a site plan to the Board for building a house on the property.

Jack A. announced that he issued a road permit to property owner Kientz for a gravel truck.

4. Approve Board Meeting Minutes - Jack Martin

Motion to approve the Board meeting minutes of May 28, 2014 – Peter A. Second – Peter A. Ayes: Jack M, Vivian A, Peter A.

5. Approve California Pavement Maintenance (CPM) proposal to slurry on Reservation Rd for \$20,406.06 – Peter Abplanalp

Peter A. conveyed that he approached CPM to request a bid for the next section of roadway to slurry. Road work is scheduled for Wednesday September 17, 2014. Slurry will be applied on Reservation Road from 5209 Reservation Road (Babbitt residence) to the end of Reservation Road at the Red Hawk boundary gate (King residence).

Roadway will be closed from 9:00am to approximately 5:00pm on September 17, 2014 for safety reasons. Notice will be posted 30 days in advance of work.

The \$200 fine violation amount approved by the Board on April 30, 2014 for the road closure on May 14, 2014 for slurry work will apply to violations of the road closure on September 17, 2014.

The Road Work Party on July 12, 2014 patched portions of Reservation Road in preparation of the slurry work on September 17, 2014.

Motion to approve CPM proposal to slurry on Reservation Rd from Babbitt residence across bridge and up Reservation Rd grade and ending at King residence (Red Hawk boundary gate) for \$20,406.06 – Jack M.

6. Approve Wade Ehrlich General Engineering proposal for culvert and roadside drainage restoration and preventive maintenance for \$14,290.00 – Peter Abplanalp and Roads Committee

Barb S. conveyed that the Roads Committee received several bids for culvert and drainage restoration work and the Committee selected Wade Ehrlich General Engineering to perform the work.

Barb S. explained what the work would entail:

- 1. Install a grate over the culvert at the corner of Turkey Track Road and Reservation Road
- 2. Ditch cleaned out and rock placed for drainage on Reservation Road, west side of the bridge
- 3. Ditch cleaned out and rock placed for drainage on Reservation Road, past Stones Throw Road
- 4. Culverts and ditching cleaned out so water will flow properly on upper Little Brush Ridge Road
- 5. Bot dots installed on the roadway approaching the bridge to slow drivers down on the steep slope to the bridge. These will be placed after the slurry work is completed on September 17, 2014.

Barb S. conveyed that this work would be performed the first week in August 201.

Motion to approve Wade Ehrilch General Engineering proposal for culvert and roadside drainage and preventive maintenance on Little Brush Ridge Rd and Reservation Road for \$14,290.00 – Vivian A.

7. Approve Joe Vincini, Inc. proposal to repair 600' of Little Brush Ridge Rd. with 2" asphalt overlay for \$13,150.00 – Peter Abplanalp and Roads Committee

Peter A. and Barb S. explained that the upper section of Little Brush Ridge Road is in need of repair and that gravel from driveways is further damaging the roadway.

Motion to approve Joe Vincini, Inc. proposal to repair 600' of Little Brush Ridge Rd with 2" asphalt overlay for \$13,150.00 – Jack M.
