6. Consideration and Adoption of Operating Rules Pursuant to Article VI, Section 1(a) of the GRHA By-Laws – Board

Jack M. conveyed that since the proposed Resolution 17-01 and the proposed Operating Rules 17-01 through 17-09 were provided to the Board on May 28, 2017, providing about a four (4) week review and comment period, he will impose a time limit for discussion of this agenda item.

There was discussion about the second notices of 2017 Spring Easement Cleanup responsibilities have been mailed. Rama P. conveyed that she researched prior year's Board meeting minutes that mentioned the sending of second notices regarding easement cleanup but did not see any mention of fines being levied to property owners still in violation. Michael A. conveyed that the Board has been

negligent in this area as the process of actually fining a property owner takes a long time and there is a need to address the situation in a timely manner.

Rama P. conveyed that she is not opposed to a more timely manner to fine violators but is concerned with the abuse of power by the Board with the Operating Rule 17-06 providing a range of dollar amounts of fines instead of a schedule of fine dollar amounts. Glen P. conveyed that he agrees with fining violators and that accountability is important, but believes the upper fine of \$5,000.00 is too wide open.

Dick N. conveyed that when the Board approves the imposition of a fine, the property owner has the right to request a review by the GHRA's Compliance Committee. Dick N. also conveyed that the Compliance Committee would have the authority to affirm, deny or increase any fine imposed on a property owner. This Compliance Committee would be a standing committee as identified in Operating Rule 17-07.

Jack M. conveyed that a motion will be taken on the proposed Resolution and proposed Operating Rules as a whole and not individually.

DISCUSSION ITEMS

7. Replenish the Reserve Fund money used for South Reservation Road work

Michael A. conveyed that he wanted to confirm what funds will be used for the road work at the South end of Reservation Road since the work was exceed by \$9000. Discussions in a previous Board meeting agreed to go ahead to borrow the money from the Reserve Fund and replenish the Reserve Fund after July invoices are paid enough to transfer the monies.

8. Roads Committee update to the Board on "2017 Spring Easement Cleanup"

Michael A commented that there are 30 letters to property owners that will be mailed to take care of trimming trees overhanging the roadway. Trees overhanging the roadway need to be trimmed up to 14 feet.

9. Treasurer Update – Melanie O'Donnell
