#### 3. Board Member General Comments Chair, Legal Affairs Committee, General Comments

Jack M. conveyed that he approved the tree cutting request for Debbie Finch.

Dick N. conveyed that the land locked parcels have been formally taken into Tribal trust. The Tribe represented to the BIA that the Tribe will create a 100 foot or 50 foot buffer zone between the parcels and Slate Creek.

# ACTION ITEM

4. Approve Board Meeting Minutes – Jack Martin

Motion to approve Board meeting minutes of September 27, 2017 – Jack M. Second – Melanie O.D Ayes: Jack M, Vivian A, Melanie O.D Nays: None

5. Consideration and Adoption of Resolution 17-02, Amendment of Operating Rules 17-03 and 17-04 and Promulgation and Enactment of Operating Rule 17-10 – Dick Nichols Dick N. explained Resolution 17-02 regarding the uncertainties of the tree cutting rule and sanctions of easement clearing. The Declaration of Covenants and Restrictions (C&R) Article V Building Restrictions, Section 1 - (f) dealing with tree cutting and Operating Rule 17-03 prohibits the cutting of trees 6 inches or greater in diameter and makes it a sanctionable offense in doing so. Some members/residents ascertain they are only cutting dead trees and did not think dead trees were included in the rule. Operating Rule 17-03 is being amended to identify trees being dead or alive. Also contains the procedure of obtaining permission to cut down trees.

Dick N. explained the changes to 17-04, pointing out that the remedy letter really does not apply for cutting trees but does apply for items that can be remediated.

Harry R. asked what the amount of the sanction can be. Dick N conveyed that a range of \$25 to \$5000 could be levied based on the situation and further explained the reasoning for the amounts – repeat offender, how much damage, etc.

Board has discretion in setting the sanction amount. Member has right to attend and defend his/her position. Dick explained the role of the Compliance Committee in situations of sanctions against a member, as identified in Operating Rule 17-07.

Harry R. indicated that he did cut down a branch and tree because of branches that did come down and tree appeared to be dead. Thought 6-inch rule did not pertain to dead trees and thought it was a service to the Association to remove it.

Jack M. explained to Ryan N (new property owner of 5441 Reservation Road) the Easement Cleanup notice and what is required by all members. Ryan N. asked if a certified arborist comes out and identifies trees that need to be removed, can they just be removed. Jack M. explained the procedure of notifying a Board member for approval for tree cutting, even when certified by an arborist.
