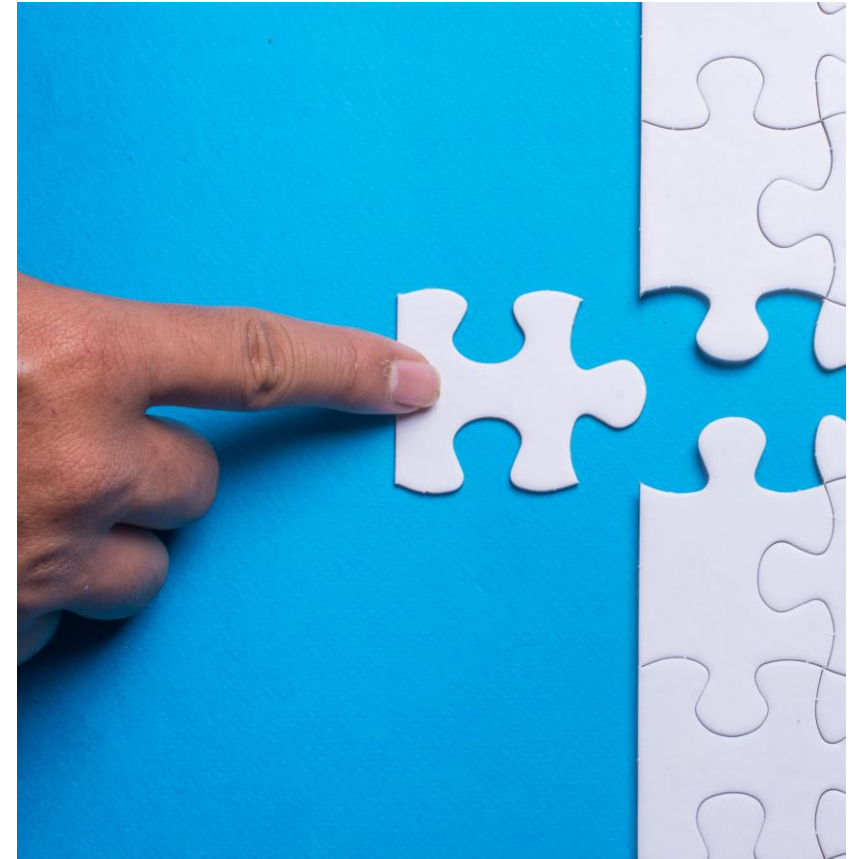
# About our Partnership

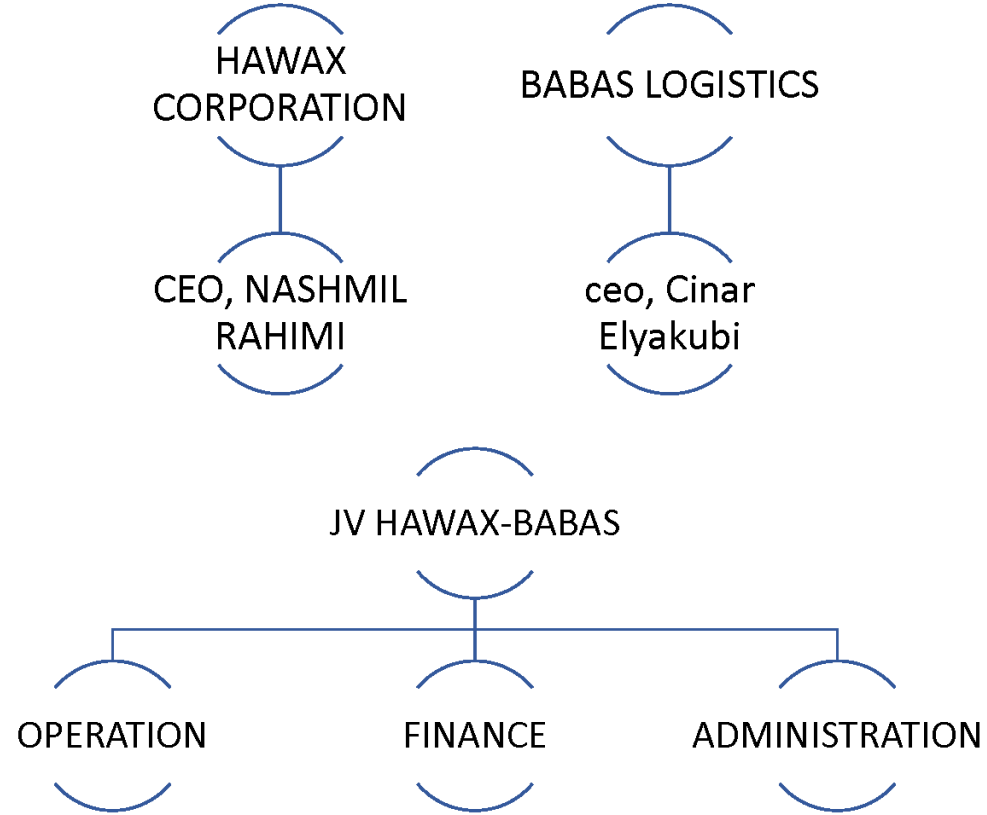
