The following are rules on the Coach and if broken could result in an immediate cancelation of the transport at the drivers discretion.

- No smoking

- No underage drinking (21)
- No standing on seats
- In order to prevent excessively large spills, kegs and barrels of beer, or water coolers filled with liquids are prohibited
- Guests are welcome to bring their own alcohol beverages and enjoy them while riding the coach. However, guests may not carry open containers of alcohol off the coach.
- If you do spill, please clean it up right away.
- No guns and knives
- While the coach is in motion, passengers can not stand near driver or the exit doors
- No sitting on the cooler or back of seats
- No glitter and confetti
- Please use the party pole in a safe manner by keeping feet on the floor
- Standing while bus is in motion could result in passenger injury. Premier Party Coach is not responsible for any injuries due to a passenger who stands while the bus is in motion.

DEPOSIT & PAYMENT & GRATUITY

A valid credit card is required to hold your date and serves as a security deposit for any damages. Full payment is due upon the time of pick-up. The full payment can be made in CASH or CHECK. CHECKS must be made out to Premier Party Coach.

If paying by CREDIT CARD a 3.5% fee will be added to the total.

DAMAGE POLICY & FEES

 - Damage to Lights, TV, or Equipment
 - Excessively Spilled Fluids • ANY Bodily Fluids discharged on Coach
- An automatic \$200, will be charged to the credit card on file
