Black Lives Matter: A Call to Action

We are living in a time of social unrest and instability. The death of Mr. George Floyd and so many other Black men, women and children at the hands of the police authorities has angered people around the world and



fueled the Black Lives Matter (BLM) movement. The BLM movement demands that we focus our attention on the creation of a "just" and "inclusive" society where ALL people are treated as members of the human race with an opportunity to live with dignity and respect. As forensic social workers we find ourselves directly linked to these issues as our work intersects that of the "Justice" system. As such, we must "ready" ourselves when called upon. In our various roles as Forensic social workers we can purposely intervene and be proactive by building allyship with members of the Black/African communities and organizations, by engaging in continuous cultural competency development and providing culturally proficient services in areas of practice such as child protection, youth criminal justice, adult criminal, corrections and mental health. As the struggle for justice continues the demand for forensic social workers as social justice advocates, navigators, disruptors, generalists and master clinicians will continue to increase. The career opportunities for forensic social workers is expanding as a result of the deaths of Black people at the hands of the police. As change-makers, social justice advocates and legal navigators, the Call to Action is to address the discrimination, prejudice, racism through social and law reform. The death of George Floyd has changed the world in terms of how we think, talk and respond to the issue of race. What can social workers in private practice do?

It depends on the social worker!

Depending on their specializations, they might:

- address mental health, addiction, trauma, grief and loss, or relationship and adjustment issues
- offer anger, stress and crisis management
- perform mediation, dispute resolution, custody & access and capacity assessments
- use therapy modalities such as CBT, DBT, or EMDR
- use age, gender and culturally-sensitive interventions

Professional Spotlight



Meet Melani Carefoot MSW RSW Calgary, Alberta Interview by> Rebecca Foslake-Luke.

What area of forensic social work are you practicing and where?

I am currently practicing in Calgary, but I have on occasion virtually assisted clients in other parts of Alberta. My areas of practice are in child welfare, as well as parenting coordination and litigation support for family law applications.

When did you get into forensic social work?

Throughout my career my practice has often intersected with the legal profession. I worked for the government in child protection as a team lead for many years. I retired in 2012, but eventually opened up my private practice due to the number of lawyers needing litigation support and consultation on complex child welfare applications.

Why do you think it's important for social workers to have an understanding of the law and legal system?

When the legal system and social work intersect, I believe that it is very important that the professionals involved understand each other's roles and

strengths. Decisions that are made in court, or by consent, often have implications for the family system, and this is an area that most lawyers are not trained in.

What advice can you give to individuals getting into forensic social work? Remember that you have lots of skills and information to share as well as learning from others. Forensic social work is a model that allows the professionals to use their education, training, and skills to complement lawyers, which lead to better outcomes for clients. It is important to make connections as you start your career, and make sure that lawyers understand how social workers can assist and enhance their practice.




