Honorable Dennis J. Curran, Justice of the Massachusetts Superior Court (Ret.), has been a prime proponent of the use of (alternative) dispute resolution to avoid the expense and trauma of a court trial.

He chaired the Superior Court Committee on Alternative Dispute Resolution, and has presented at dozens of educational programs, including two presentations to delegates from Nigeria. He has long advocated the principle of "presumptive mediation" in our trial courts, in which before a trial is called, the parties are strongly encouraged, but not mandated, by a judge, to seek to resolve their conflict by mediation or arbitration. This judicial approach has dramatically reduced court case backlog.
