ADMINISTRATOR REPORT: Andrew Gephardt reports: Absent, Mayor Suter reports

## FISCAL OFFICER'S REPORT: Bill Gilpin reports:

Ordinance 2019-14 is for council approval of the 2020 tax budget that the finance committee has recommended for adoption. Mayor Suter last month suggested the village donate the remainder of the money on hand from disaster relief donations be donated to the Dayton area tornado relief effort. The consensus of council was to donate the \$416.25 on hand to Matthew 25 Ministries. The health, dental, vision and life insurance coverage switchover is complete with the associated savings being realized. Our liability insurance will be reviewed for additional quotes to see if any money can be saved.
