# **ADMINISTRATOR REPORT:** Andrew Gephardt reports:

Andrew Gephardt noted the food vendors that are lined up for July 3; our normal DJ is not available this year; asked for input on alternate suggestions. Mayor Suter noted that we need to be careful with the amount of food vendors allowed due to limited electrical connections available. Phil Turner noted he would only be in favor of alcohol sales if the proceeds were used to offset the event cost. Debbie Roark noted that she prefers to keep the event simple like usual. Mayor Suter noted that the only way to expand the event would be to let a vendor handle the event.

It was reported that there are unlicensed vehicles throughout the village; some people are speeding and ignoring stop signs; there is a trampoline on property in the village right of way.

Andrew Gephardt reported that 314 3<sup>rd</sup> Street has been sold and that the cleanup enforcement process will need to start over again.

Rick Beasley reported that on 4<sup>th</sup> Street there are pine trees that completely block the sidewalk and asked that it be addressed.

Reported working on the 2022 tax budget noting that new funds will need to be opened when the new utility charges take effect.

ORDINANCE 2021-07 – AN ORDINANCE ESTABLISHING A CHARGE FOR SOLID WASTE REMOVAL AND RECYCLING SERVICES IN THE VILLAGE OF MOSCOW AND DECLARING AN EMERGENCY, Second Reading

Debbie Roark asked if the ordinances could be changed to a January 1, 2022 start date to allow time for residents to prepare for the additional expense. Mayor Suter asked her if she wanted to make that a motion.

\*Motion to modify the effective start date of Ordinances 2021-06 and 2021-07 by Roark. There was no second of the motion.

Todd English and Phil Turner noted that there may need to be changes made to the ordinances prior to passage. After discussion the consensus of council was to re-word the ordinances to clarify that trash collection would be billed per household and sewer fees would be billed at the rate of \$20 per household and \$10 for each vacant lot that contains a sewer tap.

Rick Beasley noted that he feels the village should be required to pay for properties it owns that contain sewer taps. Mayor Suter replied that it would only result in moving money around within the village budget.

Tracey Suter asked if a landlord is able to bring in trash from outside the village and use village dumpsters. Mayor Suter replied no.

Joe DaGiau asked if maintenance could clear debris from the riverbank more often.

It was asked if the river bank will be sprayed this year. Mayor Suter noted that the river bank must be sprayed each year due to an agreement made years ago with the Army Corps of Engineers.

Tracey Suter noted that a few years ago council donated a portion of their salary to fund the July 3 fireworks.
