Reported working on the 2022 tax budget; noted an issue with the IRS making a mistake with the village's account; the ARP revenue discussion with Ohio townships has been delegated to the state level; the local government fund will stay the same in the upcoming state budget.

SOLICITOR'S REPORT: Emily Supinger reports:

The changes to ordinances 2021-06 and 2021-07 were reviewed. Ordinance 2021-06 now calls for a \$20 monthly charge for properties that are connected to and are served by the sewer system and a \$10 monthly fee for properties that have a sewer tap but no active service on them. Ordinance 2021-07 has been updated to state a \$20 monthly fee for properties that have a dwelling on them.

MAYOR'S REPORT: Mayor Suter reports:

Reported that there was a wedding in the gymnasium over the weekend that got out of hand with people all over the building and on the roof of the building; the fire alarm was also activated. Mayor Suter has instructed Steve Roark that the gates in the hallways be locked for the weekend from now on. There was discussion on increasing the security deposit for events over 50 people. Cindy Gorth suggested installing cameras in the upstairs hallway. Emily Supinger noted that the rental contract allows for billing of additional cleanup costs when they occur. Andrew Gephardt will calculate the additional cost and bill the renter.
