WHEREAS, the Council of the Village of Moscow wishes to establish and confirm regular meeting place, dates and times as well as the method of providing notice of special council meetings;

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Moscow, Clermont County, Ohio, that:

SECTION I Regular meetings of the Council of the Village of Moscow shall be held on the first Monday of each month at 6:00 p.m. at the Moscow Community Center, 30 Wells Street, Moscow, Ohio 45153. The date and time of a regular meeting may be changed or cancelled, and the place of a regular meeting may be changed, by a majority vote of Village Council. Notwithstanding the foregoing, the Mayor may cancel a regularly scheduled meeting in the event he is advised that there will not be a quorum present to conduct business, and may authorize that the meeting be held by video-conference or teleconference as permitted by law due to the ongoing COVID-19 pandemic.

SECTION II Pursuant to Ohio Revised Code Section 731.46, a special meeting of Village Council may be called by the Mayor of the Village or by any three members of Village Council upon at least 12 hours' notice to each member, served personally, or left at his or her usual place of residence. A Notice of Special Council meeting shall be posted at the Moscow Community Center at least 24 hours' prior to the meeting.



WHEREAS, The Village of Moscow maintains a sanitary sewage system consisting of a wastewater treatment plant and associated service lines (“Sanitary Sewage System” or “System”); and

WHEREAS, Due to the loss of revenue from various sources, the Village can no longer provide sanitary sewage services to properties free of charge; and

WHEREAS, It is necessary for the Village to assess a sewerage charge upon all lots, lands, and premises served by or having a connection with the Sanitary Sewage System;

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Moscow, Clermont County, Ohio, that:

SECTION I That Village Council hereby determined that it is necessary for the protection of the public health, safety, and welfare of the Village of Moscow and its residents to establish and collect charges for the use of the Sanitary Sewage System upon all lots, lands, and premises served by or having connection with the Sanitary Sewage System.

SECTION II That the Fiscal Officer is hereby authorized to establish a fund within the Village Budget to be entitled "Sewer Fund." All monies received from the collections of the charges provided herein shall be placed in the Sewer Fund, and shall be used for the operation, maintenance, repair, and management of the System, and for debt charges on bonds issues to provide for any improvements or extensions to the System.

SECTION III That, effective July 1, 2021, a fee in the amount of \$20.00 per month shall be imposed against all lots, lands and premises connected to and served by the Sanitary Sewage System. A fee in the amount of \$10.00 per month shall be imposed on all lots, lands and premises containing a sewer tap only, with no active service. In the event that multiple parcels are served by one sewer connection, only one fee shall be charged for all parcels associated with the connection.

SECTION IV That the charge shall be billed to the owner of any lot, land, or premises served by or having connection with the Sanitary Sewage System on a quarterly basis, which shall be payable as stated on the billing.

SECTION V That each charge levied pursuant to this Ordinance is hereby made a lien upon the premises charged therewith, and if the same is not paid within ninety (90) days after it is due and payable, it shall be certified to the Clermont County Auditor, who shall place the same on the tax duplicate, and be collected as other municipal taxes are collected.

SECTION VI No lot, parcel of land, building, or premises owned or used by the Village of Moscow for municipal purposes shall be subject to the sewer charges provided herein.

SECTION II That the Fiscal Officer is hereby authorized to establish a fund within the Village Budget to be entitled "Garbage and Recycling Fund." All monies received from the collections of the charges provided herein shall be placed in

the Garbage and Recycling Fund, and shall be used to pay for solid waste removal and recycling services.

SECTION III That, effective July 1, 2021, each dwelling unit eligible for solid waste removal and recycling services shall be charged a fee in the amount of \$20.00 per month.

SECTION IV That the charge shall be billed to the owner of each dwelling unit on a quarterly basis, which shall be payable as stated on the billing.

SECTION V That each charge levied pursuant to this Ordinance is hereby made a lien upon the premises charged therewith, and if the same is not paid within ninety (90) days after it is due and payable, it shall be certified to the Clermont County Auditor, who shall place the same on the tax duplicate, and be collected as other municipal taxes are collected.

OR PARTIALLY IN THE COUNTY, WITH THE
GREATEST POPULATION**

- WHEREAS,** Ohio Revised Code Section 5747.53 authorizes adoption of an alternative method for determining the amount to be apportioned from the Undivided Local Government Fund among the various political subdivisions within a county; and
- WHEREAS,** adoption of an alternative method of apportionment for the Undivided Local Government Fund requires the approval of the Board of County Commissioners, the legislative authority of the city, located wholly or partially in the county, with the greatest population, a majority of the Boards of Township Trustees, and legislative authorities of municipal corporations, located wholly or partially in the County; and
- WHEREAS,** Ohio Revised Code Section 5747.53 permits annual resolutions to exclude the approval otherwise required of the legislative authority of the city, located wholly or partially in the county, with the greatest population; and

WHEREAS, the Village of Moscow in Clermont County, Ohio, desires to approve the alternative method for allocation of the Undivided Local Government Fund as proposed by the majority of township trustees and legislative authorities of municipal corporations for calendar year 2022.

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Moscow, Clermont County, Ohio, that:

SECTION I Pursuant to Ohio Revised Code Section 5747.53, approval of the City of Milford, as the city located wholly or partially in the county with the greatest population, shall not be required to approve the calendar year 2022 allocation of the Undivided Local Government Fund.

SECTION II That the distribution of the Undivided Local Government Funds be distributed for 2022 through 2024 on the following basis:

1. The County will receive 48.545 percent of the total allocation to be disbursed.
2. The remainder of the funds (51.455 percent) after the County allocation outlined in item 1 above will be disbursed as follows:
 - a. Fifty (50%) percent of the remainder will be shared equally among all municipalities and townships.
 - b. Fifty (50%) percent of the remainder will be distributed to the municipalities and townships on a per capita basis and will be adjusted as necessary based upon the most current United States Census.
3. A chart illustrating the proposed funds to be distributed is attached as Exhibit A and incorporated by reference.

SECTION III That the Fiscal Officer shall deliver a certified copy of this Resolution to the Clermont County Board of County Commissioners and the Clermont County Budget Commission.

SECTION IV Council hereby finds and determines that all formal actions relative to the passage of this legislation were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION V That this resolution shall take effect from and after the earliest time allowed by law.

SECTION II This Ordinance shall take effect at the earliest period allowed by law.



WHEREAS, Village Council adopted Ordinance No. 2021-06 establishing a sanitary sewerage charge for properties served by or connected to the Village of Moscow Sanitary Sewer System; and

WHEREAS, Council desires to amend and restate Ordinance No. 2021-06 in order to include a late fee for unpaid bills;

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Moscow, Clermont County, Ohio, that:

SECTION I That Ordinance No. 2021-06 is amended and restated as provided herein.

SECTION II That Village Council hereby determined that it is necessary for the protection of the public health, safety, and welfare of the Village of Moscow and its residents to establish and collect charges for the use of the Sanitary Sewage System upon all lots, lands, and premises served by or having connection with the Sanitary Sewage System.

SECTION III That the Fiscal Officer is hereby authorized to establish a fund within the Village Budget to be entitled "Sewer Fund." All monies received from the collections of the charges provided herein shall be placed in the Sewer Fund, and shall be used for the operation, maintenance, repair, and management of the System, and for debt charges on bonds issues to provide for any improvements or extensions to the System.

SECTION IV That, effective July 1, 2021, a fee in the amount of \$20.00 per month shall be imposed against all lots, lands and premises connected to and served by the Sanitary Sewage System. A fee in the amount of \$10.00 per month shall be imposed on all lots, lands and premises containing a sewer tap only, with no active service. In the event that multiple parcels are served by one sewer connection, only one fee shall be charged for all parcels associated with the connection.

SECTION V That the charge shall be billed to the owner of any lot, land, or premises served by or having connection with the Sanitary Sewage System on a quarterly basis, which shall be payable as stated on the billing. Any bill not paid when due shall have a late payment fee of ten per cent (10%) of the unpaid amount added to the next statement.

SECTION VI That each charge levied pursuant to this Ordinance is hereby made a lien upon the premises charged therewith, and if the same is not paid within ninety (90) days after it is due and payable, it shall be certified to the Clermont County Auditor, who shall place the same on the tax duplicate, and be collected as other municipal taxes are collected.

SECTION VII No lot, parcel of land, building, or premises owned or used by the Village of Moscow for municipal purposes shall be subject to the sewer charges provided herein.

WHEREAS, Village Council adopted Ordinance No. 2021-07 establishing a charge for solid waste removal and recycling services in the Village of Moscow; and

WHEREAS, Council desires to amend and restate Ordinance No. 2021-07 in order to include a late fee and to more clearly specify the procedure for certifying unpaid fees to the County Auditor;

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Moscow, Clermont County, Ohio, that:

SECTION I That Ordinance No. 2021-07 is hereby amended and restated as provided herein.

SECTION II That Village Council hereby determined that it is necessary for the protection of the public health, safety, and welfare of the Village of Moscow and its residents to establish and collect charges for the collection and disposal of solid waste and recycling services.

SECTION III That the Fiscal Officer is hereby authorized to establish a fund within the Village Budget to be entitled "Garbage and Recycling Fund." All monies

received from the collections of the charges provided herein shall be placed in the Garbage and Recycling Fund, and shall be used to pay for solid waste removal and recycling services.

SECTION IV That, effective July 1, 2021, each dwelling unit eligible for shall be charged a fee in the amount of \$20.00 per month.

SECTION V That the charge shall be billed to the owner of each dwelling unit on a quarterly basis, which shall be payable as stated on the billing. Any bill not paid when due shall have a late payment fee of ten per cent (10%) of the unpaid amount added to the next statement.

SECTION VI That Village Council may certify to the county auditor, by ordinance, the amount of the fee that has not been paid in accordance with this Ordinance when either of the following applies: (i) the unpaid amount is equal to or greater than two hundred fifty dollars; or (ii) the unpaid amount is equal to or greater than the applicable annual rate or charge imposed by this Ordinance. The amount certified shall be a lien on the person's property to which services are provided, placed on the tax duplicate, and be collected as other municipal taxes are collected.
