LINCOLN-DOUGLAS DEBATE

EVENT RULES & ORDER OF DEBATE

An argumentative resolution (*debatable topic*) will be distributed to SCSTA Coaches approximately two weeks prior to the competition. Debaters must be prepared to argue **BOTH** the affirmative (*in support of*) and negative (*against*) side of the resolution. **One minute prior to debate, speakers will randomly select which side of the debate they will argue (***Affirmative or Negative***). Speakers are encouraged to prepare, research, and practice both sides of the argument. Lincoln-Douglas Debate follows the Order of Debate**. The debate will be judged on knowledge/originality, organization, content, delivery, and overall effectiveness (*including who won*).

TOTAL TIME: 15 minutes per debate

Resolution is the topic of the debate. Resolution must be argumentative with a variety of logical options for either side of the argument. **Students must come prepared to speak on both the affirmative AND the negative side of the argument**. *Sample resolution: National security should be valued above freedom of the press.*

- 1. **Affirmative Speaker's Opening Argument**: 3 minutes maximum. Affirmative Speaker presents his/her prepared persuasive speech **in support of** the resolution. (30 seconds preparation)
- 2. **Negative Speaker Cross Examines Affirmative Speaker**: 60 seconds maximum **Q & A**. Negative Speaker challenges the Affirmative Speaker's opening argument. (30 seconds preparation)
- 3. **Negative Speaker's Opening Argument**: 3 minutes maximum. Negative Speaker presents his/her argument **against the resolution** AND **refutes Affirmative Speaker's** opening argument. (30 seconds preparation)
- 4. **Affirmative Speaker Cross Examines Negative Speaker**: 60 seconds maximum **Q & A**. Affirmative Speaker challenges the Negative Speaker's opening argument. (30 seconds preparation)
- 5. **1**st **Rebuttal by Affirmative Speaker**: 60 seconds maximum. to address opponent's response to questions. (30 seconds preparation)
 - > Summarizes the major objections to the Negative Speaker's argument.
 - ➤ Calls attention to the weaknesses in the negative case (*fallacies, unproved claims, etc.*).
- 6. **Rebuttal by Negative Speaker**: 90 seconds maximum to offer a final response against the Affirmative Speaker's argument. (30 seconds preparation)
 - ➤ Summarizes the major objections to the Affirmative Speaker's argument.
 - > Re-establishes the Negative Speaker's argument against the resolution.
 - > Calls attention to the weaknesses in the affirmative case (*fallacies, unproved claims, etc.*).
 - > Asks for acceptance of the negative position by the audience/judge.
- 7. **Final Rebuttal by Affirmative Speaker**: 60 seconds maximum to offer a final response to the Negative Speaker's argument and rebuttal.
 - ➤ Re-establishes the Affirmative Speaker's argument in support of the resolution.
 - ➤ Asks for acceptance of the affirmative position by the audience/judge
