2020 Tax Plan for the United States Government

All examples are based on a 40,000 a year income. I don't have an average income based on companies, but we will touch base on that in the future. Based on an average of 200 million working people is 800 billion a year just on 40k salaries. The people's money is put into an account and then the amount of their tax dollars are transferred into an account only they have access to these are only digits that represent their tax dollars not the actual dollars and I'll explain why. Now only they have access based on their SSI number and blockchain tech that they will have access to based on the security they set up to protect their account. Remember these are only digits that represent their tax dollars not the actual dollars so no one can hack in and steal actual dollars.

10% flat Rate plan across the board for all citizens and work visas.

12.5% for small businesses under 100 employees

15% flat rate for all companies and corporations that are strictly based only in the United States. 20% flat rate to all companies that have business in other countries and work out of them as well.

Investments and dividends we will work out a fair low percent as well. I don't know enough about them to throw out a number just yet.

Overtime hours are non-taxable Secondary job is non-taxable

Students only pay a \$10.00 a month tax and it all goes into their account so they have a chance to use the system and get accustomed to the tax system. If they work.

No Death Tax !!!! The Death tax is removed.

Farmers/Ranchers are 100% tax-exempt, but pay taxes if they have alternative jobs Accounts are set up for them to still donate.

Veterans that serve 20+ years are tax exempt. If wounded in battle during service, they are tax exempt. While serving on active duty they will pay 10% tax. For every 2 years of active-duty service, they will receive a 1% reduction in tax burden.

Example 1: A citizen serves 4 years in the military; their tax burden is reduced by 2%. They then pay 8% in federal taxes for the rest of their life.

Example 2: A citizen serves 10 years in the military; their tax burden is reduced to 5% until they reach 20 years of service. After 20 years of military service, they pay 0% in federal taxes for the rest of their life.

The money is divided into several categories as follows.

There are 3 tiers that money will go into as funds.

Tier 1 fund will consist of the highest priority of our nation such as but not limited to. The military pay, national defense, SSI "because we made a promise to the people to help with their retirement and people were foolish enough to believe anything out of the government's mouth" and non-elected officials' paychecks, aka government employees our national parks and monuments upkeep, Border Security, our national debt that needs paid back to our lenders and say a rainy day fund for national disasters. This is the basis for the 1 tier we can discuss maybe a few other things I missed but this is just the example.

Tier 2 funding is where the nuts and bolts really come together. In this Tier, you will have the President's salary and the congress and senate as well.

In this category, Congress will receive budgets from the country that needs funding for example Let's say Planned Parenthood says they need funding or grants call it what you want doesn't matter under this system, but they need 100 million dollars for women's free healthcare. Let's say to build a wall across our border needs an annual budget of 300 million dollars a year .. let's say Nasa needs 400 million dollars, let's say we need 100k for turtle tunnels or 500k for the study for lesbian bikers and why they are fat. Or 100k for the study of what effect Cocaine has on the Japanese quail's sex life. By the way, these are all real funds we the taxpayers paid for the last few years.

Now here is where Congress has to really do their job, Congress gets all the budgets that are needed for the following year. You know our budgets that were supposed to follow. This plan ensures we never go over budget or in debt and no matter if you back Planned Parenthood or build the border wall or oppose them both everyone can agree with this system.

Now congress takes all these programs and their budgets, and they have to decide which tier 2 or 3 they go in.

Let's say for basic understanding here is the tier 2 layout.

Tier 2 = President's salary-450k Senate Salary- 17.4 million Congress Salary- 75.6 million Planned Parenthood-

100 Million Infrastructure -

500 Million?

Congress individual allotment-435 members 300k each

=130,500,000 Scientific Discovery- 300 Million

Border Wall- 300 Million

These are just some examples I put Planned Parenthood and the Border Wall in for a reason I'll get to in a minute as examples.

Tier 3 would be all the programs I would put in like...

Cocaine effects on Japanese Quail and its sex life... 100K

A study on why Lesbian bikers are fat... 500k

Turtle tunnels ... 100K

As you can see Tier 3 should be for all the Bullshit programs that really should not see any taxpayer funding but should raise their money on their own.

Ok, the Corporations and Businesses pay their annual of 12.5 or 15% as addressed earlier into the Tier 1 Base all of it goes there.

Now back to the Salary of the US Citizen of 40k a year average. Now 10% of 40k is 4k so this is what each Citizen pays into taxes. Now we at first split this up in half until I can see numbers that show the Corporations/Business can basically fund the Tier 1 on their own. But for this example, it's cut in half for the citizen 2k out of their 4k goes into Tier 1 as well. Now the other 2k goes into an account under their name and SSI #. Now the actual money goes into a general fund but credits for their taxes go under their name. Here is where the fighting with congress stops dead in its tracks.

The citizen gets to take the \$2k credits they paid in and they look over the programs on a website the govt. sets up showing the Tier 2 programs and tier 3 programs. Now the citizen takes the credits they paid in and divide it up into the programs they agree with. You see their tax dollars are spent the way they see fit not some politician. Now under the Congress and Senate salary, you can click on it and pick out a certain Senator or Congressmen and donate whatever money you feel they deserve based on their ability to represent their district or state. If you do a good job as my representative, I'll toss a few bucks into your salary same as the President's. This way my tax dollar is not going to a senator or congressman not even in my state. Now no one can put any money into Tier 3 until you as a citizen has put at least 80% of your credits into Tier 2 then you can start putting money into Tier 3. Once a program in Tier 2 hits its max goal then the Program closes and no one else can put into it. See that budget is Met based on the American

people deciding whether it was a worthy program or not. So congress has to do their jobs and keep their people happy or they probably won't get paid. Now people who make more than \$40k, say \$100k, pay \$10k in taxes; \$5k goes to Tier 1 and they get \$5k to spend on our budget. You see the American people are smart enough to know where their money should go. Here is the best part, if the so-called rich like to say "I wish they could do more" like Warren Buffet says it's not right his secretary pays more taxes than him well now Mr. Buffet you can do more and put extra money into your account and pay extra taxes. There will be a link that any Citizen can donate more of their own money into their own account and get more credits to put forth into programs they see fit and once you donate extra money than what is required you can put that extra cash into any of the 3 Tiers they want.

Now with all these programs that people will be looking at to donate their money into will be a link beside each program with a short video of let's say 60 seconds describing why you should donate to their fund. You know inform the people of what the program does and intends to do that will benefit the country.

You can also put a spot next to each taxpayer ID whether their registered to vote and on Election Day everyone can go in and click the button to say they voted. Now at end of an election if the vote count doesn't match what people clicked their tab could be signs of voter fraud. There are other things we could do to this as well that would work; open to ideas.

You see this type of system really puts a damper on corruption these congressmen won't be able to push certain programs and get kickbacks. Now, these places will have a hard time bribing the politician with campaign financing because now there is no guarantee that the program will see any money from the taxpayers and Congress won't overload the Tier 2 because of the fear of not getting their own salary and budget reached. This will keep a better track of checks and balances. Personally, I would put Planned Parenthood in Tier 3. Now there is one other different aspect I would also like to see 2 additional criteria for Tier 2. One is on top of the State Grants that each individual Congressman gets to add a budget for let's say up to \$300k that would go to a program strictly in their own District. This way it shows they are getting something personally for their district. Now the people of their district will have to introduce what they want for their district and the congressman would have to decide which gets how much money. This allows Congress to get money for their districts without having to vote for a bill just for the leaders to allow money for them. Each congressman can bring money all on their own without bribes.

The other one I would like to see the President himself be able to add 1 program to the Tier 2 budget with let's say 100 million dollars to something they believe is important to fund that year. For Example, Donald Trump doesn't see funding for the border wall in the next year's budget he can at least put a budget himself of \$100 Million. Now that may only be able to do a smaller portion of the wall but he will be able to at least say he did what he could to uphold his promises made on the campaign trail. Still doesn't mean it gets funded if taxpayers don't put money in.

Now let's say your tax dollars must be put into programs by Jan 10th if by that time you don't do your job then Congress is able to take any tax dollars not allocated to a fund they get to choose and vote on where the money is distributed. So do your job and put your money where you want it or Congress will! Don't cry your tax dollars are wasted.

You may wonder how we will even get this to a vote well that I have a plan for that, and I know exactly how to bend the arm of these politicians I have an ace up my sleeve.
