Daniel F. Martuscello III, NYS DOCCS, Acting Excutive Deputy Commissioner

Daniel F. Martuscello III, Acting Executive Deputy Commissioner, began his career with the then Department of Correctional Services in May 1997, as a correction officer trainee. He transitioned from Security to Administrative Services in 2001, where he held a variety of titles within the Bureau of Personnel, including Director of Human Resources. In August 2012, Mr. Martuscello was appointed Deputy Commissioner for Administrative Services, and most recently to Acting Executive Deputy Commissioner for the NYS Department of Corrections and Community Supervision, making him the second highest-ranking individual in the Department. Mr. Martuscello coordinates the activities of and provides general direction to the entire Executive Team, as well as, performs special assignments at the Acting Commissioner's direction, and serves as the Acting Commissioner's principal advisor, with emphasis on labor relations, intergovernmental matters, and community issues. Mr. Martuscello holds a Bachelor of Arts Degree in Sociology, with a concentration in Criminology from SUNY Cortland.

James Brooks. Active Shooter Course

Officer James Brooks worked from 1987 to 1990 as a NYSDOCCS Corrections Officer and has worked for the Albany, NY Police Department from 1990 to the present day. He is a certified Police Instructor with the NYS Division of Criminal Justice Services/BMP, NYS DCJS/BMP Field Training Officer, certified instructor ALERRT CRASE, certified ALERRT level 1 instructor, certified ALERRT level 2 instructor, certified TECC instructor, adjunct CRASE instructor for NYSDOCCS civilian staff, FEMA/NYS DHSES instructor, NYS Gang Specialist, certified in Advanced Terrorist Attack Cycles, certified FEMA Active Shooter IS-907, and certified in US DOJ Street Gang Intelligence.


