Vendor Terms & Conditions

These Terms and Conditions govern vendor participation in the Bruneau Cowboy Christmas event. By submitting an application or participating in the event, vendors agree to comply with the requirements outlined below.

1. Event Overview

- Event Name: Bruneau Cowboy Christmas
- Dates: November 6–8, 2026
- Location: 48803 Highway 78, Mountain Home, ID 83647
- Setup: Thursday, November 5, 2026, 10:00 AM – 4:00 PM
- Event Hours: Friday 10 AM–5 PM, Saturday 10 AM–5 PM, Sunday 10 AM–3 PM
- Teardown: Sunday, November 8, 2026, 3:00 PM–6:00 PM

2. Vendor Cleanup Expectations

- Remove all merchandise, displays, tents, tables, chairs, and personal belongings.
- Remove all trash, packaging, zip ties, tape, cardboard, and debris.
- Leave your space in the same or better condition than you found it.
- Dispose of trash only in designated areas.
- Food vendors must dispose of grease, liquids, and food waste offsite.
- Report any damage to event staff immediately.
- Failure to clean your booth may result in cleaning fees or loss of future vendor eligibility.

3. Vendor Application & Fees

- Booth assignments are made at the Organizer's discretion.
- Applications are processed on a first-come, first-served basis.
- Approved booth fees are due within 14 days.
- Space is not guaranteed until payment is received and confirmed.

4. Booth Requirements

- Provide your own tent, tables, chairs, signage, extension cords, and display materials.
- Remain open during all published event hours.
- Keep displays within your assigned space.

- Secure all tents and canopies safely.

5. Permits & Taxes

- Obtain all required licenses and permits.
- Comply with applicable food safety regulations.
- Collect and report all required sales tax.

6. Conduct

- Maintain professional conduct.
- No offensive or unsafe merchandise.
- Amplified music requires approval.

7. Electricity

- Limited electrical access may be available upon request.
- Bring your own extension cords and power strips.
- Generators are permitted.

8. Insurance & Liability

- Participation is at your own risk.
- Vendors must carry general liability insurance.
- Add Quey's Farm and Bruneau Cowboy Christmas as additional insureds.

9. Cancellation Policy

- \$50 administration fee in non-refundable the balance will be refunded within 60 days of payment.
- 50% refund after 60 days through August 31 minus the \$50 admin fee.
- No refund after September 1 and vendor placed on probation for the following year.
- Weather or forced closure refunds are at Organizer discretion.

10. Indemnification

- Vendor agrees to indemnify and hold harmless the Organizer, volunteers, representatives, and sponsors.

11. Photography

- Participation grants permission for event photos and videos to be used for promotional purposes without compensation.
