

COVID-19 GOLF TOURNAMENT PROTOCOLS

To stay in line with health and social mandates and to keep everyone safe and healthy, we ask all participants to comply with the following protocols. These procedures are subject to change without prior notification as the health guidelines are fluid and evolve quickly.

- It is the responsibility of the person registering for the tournament to fully communicate these procedures to all golfers/guests in their party in advance and prior to arrival so that all golfers/guests comply.
- If you are sick, have any symptoms, or believe that you might have COVID-19 or other illness where you should not be near or around others in public, please stay home.
- Social distancing of 6 feet minimum is required throughout the event.
- Face coverings are not required when out on the golf course but will be required in all other locations on the property - Parking Lot, Clubhouse, Registration and the grounds around the Clubhouse, etc. Hand sanitizer stations are also located on property. Face coverings are recommended but optional while out on the course and when hitting balls at the range.
- Driving Range is open and golfers should follow social distancing guidelines.
- We have removed many "touch point" items from the event bunker rakes, washers, coolers, bag drop, etc. Please help us out with the following -
 - The flags on each hole on the course have been fit with a "Cup Saver" to allow the ball to enter the hole but only go down an inch or so. The ball can be retrieved without touching the flag or cup. Please do NOT touch or remove the flagstick. Putting can be fully completed with the flag in place.
 - Golf balls in bunkers can be placed for a better lie without penalty during this time.
 - Since bunkers will be without rakes, please be diligent and courteous when hitting out of a bunker. Please use your foot to "rake" the area you hit from and any sand displacement so as to leave the conditions the best you can for the next golfer.
- Clubhouse and course restrooms will be open but keep social distancing in restrooms as elsewhere on the property.

INFORMED WRITTEN CONSENT, ASSUMPTION OF RISK AND

RELEASE OF CLAIMS RELATED TO COVID-19

We are pleased that you could join us for the Orange County Automobile Dealers Association ("*OCADA*") Golf Tournament at Mission Viejo County Club ("*Tournament*"). In consideration for attending and/or participating in the Tournament, I hereby acknowledge and agree to the following:

- 1. I understand the hazards of COVID-19 and am familiar with the Centers for Disease Control and Prevention ("*CDC*") guidelines regarding COVID-19 including all social distancing and virus mitigation protocols. I acknowledge and understand that the circumstances regarding COVID-19 are changing from day-to-day and that, accordingly, the CDC guidelines are regularly modified and updated.
- 2. Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly participate and/or attend the Tournament and shall obey all social distancing and virus mitigation protocols. I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from participating or attending the Tournament and hereby release, waive, discharge, and covenant not to sue OCADA including its shareholders, officers, directors, affiliates, agents, members, employees and assigns (the "Releasees") from any liability related to COVID-19 which might occur as a result participating in the Tournament.
- 3. I shall indemnify, defend, and hold harmless the Releasees from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, costs and disbursements, whether of in-house or outside counsel and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly to COVID-19. With respect to this Informed Consent, I hereby knowingly and specifically waive any and all rights and benefits, which I now have, or in the future may have conferred by virtue of the provisions of Section 1542 of the California Civil Code, which provides:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

I HAVE CAREFULLY READ THIS INFORMED WRITTEN CONSENT, ASSUMPTION OF RISK AND RELEASE OF CLAIMS RELATED TO COVID-19 AGREEMENT, AND FULLY UNDERSTAND ITS CONTENTS. I CONFIRM THAT I WILL FOLLOW ALL COVID-19 VIRUS MITIGATION PROTOCALS DURING MY ATTENDANCE AT THE TOURNAMENT.
