## **Minutes**

Supervisor- Kienitz Opened Floor to comments on Proposed Solar Ordinance Amendments meeting.

Township Attorney Abdoo- gave brief summary on purpose and guidelines Hearing. Clerk. Wenzlick handed Board members letters from Don Wirostek, Laurcien Edgar and 8 letters from residents concerning the Ordinance being discussed. (received prior to meeting)

Dave Sadilek- Great opportunity for landowners and Township

The township is looking for revenue for a fire truck.

How can the board turn down new revenue and raise taxes?

Did the Board address new MI solar laws? Ordinance will cost serval millions in revenue. The board must make decisions based on facts.

Tom Holcomb- Property owners' rights should be restricted to solar as in other rules of township.

I would pay extra taxes, instead of looking at solar farms. People getting solar farms will not put by their home.

Cindy Braeutigan- Do not want.

If going to be put in township, we need restrictions.

Roger Callard- Legacy-Historical account of history 2-3-4 generations, what are we going to leave behind?

Promise anything, contracts can be broken.

If we put in place restrictions, they are going to benefit all.

We all live with restrictions. Let's make sure these are enforced.

Margret Harvey - toxins in panels. Concerns over damaged solar panels, leak when broken.

New bill in Lansing-set fees-because will cast lower taxes.

Ruth Wilhem- Now that Township cannot decide to have Solar Farms, that we are just setting guidelines.

Borad did not do enough studies or research to create ordinance, reconsider ordinance.

Debbi Newton-Respect, dignity, accountability, seek to be.

2018 Ordinance clear and effective at time

Clear honest leadership and integrity is needed by the Board.

We all value meaningful revised ordinance to be just for all.

Linda Locey- Property owners will not benefit, only farmers.

Concerns over health issues

Why are we putting them in, get priorities straight.
