Updated Solar Ordinance reviewed by Planning Commission Board and public present.

Public comment:-Multiple concerns by public voiced- safety concerns and need for licensed electricians, concerns of creating an ordinance wanting solar farms by Consumers Energy, property rights and green energy, don't think the ordinance is fair and does not want the township to miss out on money, citizen sited research on solar farms with no toxic contaminants, property values and contaminants, unable for citizens to enjoy their property if surrounded by solar, who regulates solar farms and who enforces the ordinance violations, would like the board to reconsider due to an email siting putting a poison pill in the ordinance, is there a contract with a company to decommission and can not regress once committed, thanked committee for their responsibility to protect residents of the township and if nothing toxic then why are not accepting solar panels at the dumps, project developer with PHD for last 10 years spoke on noise level restrictions 25% of parcel max coverage set back of 350ft all harsh, concern of when the federal dollars shut down the solar farms will not go away, concerns for future generations, disappointed in townships masterplan of 77% being agricultural pros and cons destroys ag, once solar farms established will be here for generations then sited bible verses supporting farming the land not solar, concern of farming wants to farm without restrictions, letter read aloud by Nixon family spoke on property values decreasing, concern of no good evidence not to have solar 250 acres will power 11,000 homeland township needs money to fix roads, bill 4317 and 4318 sited, consumers was mandated by the state of Michigan act 295 for green energy, coal plant in bay city shut down and will have solar on the land there, concern of land not in PA 116, concern of restrictions in all areas including building and why should solar farms not have restrictions and regulations, realtor stating to a citizen that a home sale with a deposit on it the purchaser walked away due to solar coming into the area, citizen spoke on litigation in other townships due to solar, concern of why should others have any concern of what is done with your own land.
