5. Increase Sexton yearly salary from \$2,640 to \$2,712
6. Increase Cemetery Lawn care from yearly salary \$9,800 to \$10,080
7. Increase Board and Commissions PDM from \$110 to \$113 /full day and from \$65 to \$67 /half day
8. Increase Zoning Enforcement Officer hourly rate from \$25 to \$26
9. Increase hourly employee rate from \$15 to \$16
