POLICIES AND PROCEDURES

Permits/Licensing

Vendors are responsible for all licensing and permits required by law to sell or promote their product. All vendors are required to have a Temporary Vendor Permit. Food Vendors are additionally required to have a Food Handlers Permit to participate in Conner's A-Maize-Ing Acres. A copy of these permits must be submitted.

Etiquette Policy

Alcohol distribution and consumption by vendors is prohibited. Vendors that show signs of intoxication will be asked to leave the grounds.

Fees

Food Vendors will be charged a \$100 booking deposit fee to be paid at the time of booking. And a fee of 10% of gross sales, will be due & collected at the end of each day you are here. The \$100 Deposit will be deducted from your sales.

Menu Items

All menu items may be sold, with the exception of any listed below.

Menu items to be excluded are. **Alcoholic Beverages, Smoking and Vaping Products**

Placement & Hours

For safety reasons, food trucks must be in place before Conner's A-Maize-Ing Acres opens each day and removed after closing hours. Permission is required to arrive late or depart early. The location where your truck may be parked will be determined in advance.

Sanitation

Food Trucks and areas surrounding Food Trucks must be kept clean at all times. Each Food Truck is responsible for taking your trash with you for disposal.

Daily Sales Reporting

Food Trucks are responsible for maintaining a Daily Report used to report gross sales during the event. Daily reports must be submitted at the end of each day with 10% fee.

Fire / First Aid

Each Food Truck must have an approved fire extinguisher and first aid kit in the truck at all times.

Staff

Smoking, drugs and alcohol are not allowed anywhere on Conner's A-Maize-Ing Acres property. Staff must be neat and clean, preferably in recognizable clothing, i.e. matching t-shirts or jackets. Using profanity and yelling at the customers are strictly prohibited.

Electrical Services

If you require electricity for your booth, please submit this request with your application. All vendors should bring their own electrical cords. Conner's A-Maize-Ing Acres will not provide electrical cords.

On-Site Security

Despite arrangements made by Conner's A-Maize-Ing Acres to provide excellent security protection for vendor properties, Conner's A-Maize-Ing Acres is not financially liable for losses or damages of any kind.

Displays / Signage

All displays must be neat, organized and clean. No profanity on goods/services or signage.

Indemnification

Conner's A-Maize-Ing Acres is not responsible for any injury, theft, or damage to either the buyer or seller, or their property arising out of or pertaining to preparation for or participation in Conner's A-Maize-Ing Acres; whether such injury, theft or damage occurred prior, during or after Conner's A-Maize-Ing Acres. Seller further agrees to indemnify and hold Conner's A-Maize-Ing Acres harmless of any claims for such injury, theft or damage. Provide Conner's A-Maize-Ing Acres with a copy of certificate of liability insurance coverage a minimum of 7 days prior to event, list Conner's A-Maize-Ing Acres as an additional insured for a minimum of \$1,000,000 per occurrence. Conner's A-Maize-Ing Acres may require removal of any items that become a problem for the public or other booths. Be responsible for all remittance of licenses, taxes and fees required to operate a booth.

Impossibility

Conner's A-Maize-Ing Acres reserves the right to terminate this contract if we think that there has been a misjudgment or misrepresentation of the type of booking. If the group's intentions are deemed to be controversial or inappropriate in any way, Conner's A-Maize-Ing Acres reserves the right to terminate that vendor in the festival.
