 - c. Serum Creatinine
 - d. RPR, VDRL or other serologic test for Syphilis
 - e. Stool for culture and Microscopic examination
 - f. HIV antibody test
 - g. Update immunization status including measles, mumps, rubella, tetanus and hepatitis B- 3 dose

*Immunization card **MUST** be produced.

h. Mantoux (TB) test

Persons traveling from high-risk areas or who have had recent malarial infection should be suitable treated with Promaguine.

The Medical Report <u>MUST</u> be done at any MEDICAL FACILITY in Grenada.
