- The form must be completed in duplicate and signed before a Justice of the Peace, Commissioner of Affidavits, Notary Public or an Official of similar standing.
- 3. Evidence of the applicant's place and date of birth must be submitted, i.e. certified copy of birth certificate. In the case where the applicant is a Grenadian Citizen under Section 97, i.e. born outside of Grenada after 7th February, 1974, evidence of the parent's place and date of birth must be submitted, i.e. a certified copy of the parent's Birth Certificate. If no name appears on the Birth Certificate in either case, a certified copy of the Baptismal Certificate or Original Affidavit must be submitted.
- 4. In the case of a married woman, a certified copy of the Marriage Certificate must be submitted.
- 5. Two (2) passport size photographs (50mm×50mm) of the applicant **CERTIFIED** by a Justice of the Peace or Notary Public: "I certify that this is a true likeness of....."
- 6. Grenadian passport in your possession
- 7. EC \$250.00 (equivalent to US\$.....) must be submitted in a Bank Draft (including EC \$5.10/ US \$..... banking transaction fee) or Money Order or British Postal Order made payable to the **Government of Grenada**.
