Lawn Sign Removal



As according to Article VIII. Restrictions. Section 9. For everyone's safety, all animals, must be kept on a leash and be under the physical control of a responsible person at all times while outdoors. Further, to keep our grounds clean and presentable, it's important that owner's clean up after their pets. Pet owners are responsible for collecting waste and disposing of it properly. To assist with this effort, 4 Pet Stations have been strategically installed around the complex where owners can conveniently extract plastic waste bags. Here are some safety tips from our Neighborhood Watch committee.

Work with your neighbors to keep your neighborhood clean and orderly. Keep spare keys with a trusted neighbor, not under a doormat or planter, on a ledge, or in the mailbox. Set timers on lights when you're away from home so it appears to be occupied. Illuminate or eliminate places an intruder might hide: the spaces between trees or shrubs and entry ways. Want to VOTE by Absentee Ballot?

To vote by absentee ballot, you must first fill out, sign, and submit an absentee ballot application. You can do this online, by mail, by fax, or in person. Submit your absentee ballot application by the specified deadline. Absentee ballots may be requested any time between 180 days prior to the election and the end of the business day on the Friday before Election Day.
