

## **2020** National Professional Development Grant

The **MRPF Grant Program** enables professionals in the parks and recreation field to attend a national conference/training. This grant is intended to provide professional growth and the opportunity to learn from other park and recreation professionals at a national level. One grant will be offered each year.

Recipient may attend a nationally recognized conference/training including all meetings, networking events, and educational sessions in order to expand their professional knowledge and network. After attending the recipient must write a brief evaluation report including: 1) an overview of all activities participated in; and 2) what professional growth experiences were gained and can be shared.

## **Recipient Benefits**

Selected recipient will receive a \$2,000 grant to help cover conference/training expenses, travel, and lodging. The recipient agrees to cover all other associated costs. Proof of registration must be provided to MRPF within two weeks of acceptance of the grant.

## **Minimum Eligibility Criteria**

- Must be a current member of MRPF.
- At least two (2) years of full-time work experience in the Parks and Recreation field or related.
- Must currently live or work in the state of Minnesota.
- Demonstrates an active membership in MRPF and/or MRPA over the last two years.
- Must have held a position in Minnesota responsible for program planning, administration, or supervision in the last two years. (*Preference is given to professionals who do not receive employer funding and typically would not have the ability to attend a national conference/training.*)
- Grant recipients are only eligible to receive the MRPF grant once every five (5) years.

Eligible applicants should submit application and supporting materials via email to the address below, no later than **Friday**, **April 3**, **2020**. All applications will be scored according to the point system listed above. Incomplete and partial applications will not be considered. Applicants will be notified by Monday, April 20, 2020.
