SETUP:	Setup will be from 4:00 PM until dark the day before the celebration and the morning of the celebration until 9 AM. <u>ALL</u> vehicles not given permission to be on the school grounds need to be out of the craft area by 9 AM the day of the celebration.
SECURITY:	We will have security the night before the celebration. Please read through the Rules & Policies for liability of personal properties.
TEAR DOWN:	No vehicles will be allowed in the Food or Craft area for tear down until after the Fireworks. Exit Gates must not be blocked during setup or tear down.
TAXES:	
RULES & POLICIES:	<ol style="list-style-type: none"> 1. We are on the School Grounds so please follow their rules. Smoking, Alcohol, and Firearms are <u>NOT</u> permitted on School Grounds. 2. Vendors may <u>NOT</u> sell water, alcohol, fireworks, firearms, knives, blow guns, toy guns that shoot hard projectiles, tasers, throwing stars, stink bombs (including spray cans), spray string, pornographic material, and anything advertising or promoting any illegal activities or substances on the School property. 3. Each vendor is responsible for his/her own liability. The Melba 4th of July Committee shall not be held liable in the case of fire, theft, or breakage whether willful or accidental (this includes weather related incidents). The Melba 4th of July Committee is released from liability for the loss, injury, and damage to property of exhibitor during the celebration. 4. Before the Fireworks Program (usually 10:00 PM until 10:30 PM) vendors will be required to lower and turn off overhead lights, high flags, banners, and signs so as to not interfere with audience viewing of the show. 5. After the Fireworks Program, <u>extreme caution in vehicle movement shall be exercised</u> to prevent accidents or injury. 6. The 4th of July Committee reserves the right to remove any vendor who is found in violation of these rules and policies at any time.


