Continuation of work to support SB73 - Sextortion Bill

PATH continues to engage in work to support the implementation of Kentucky Senate Bill (SB) 73, which went into effect on June 25th, 2025. The "Sextortion Bill" strengthens laws against sexual extortion by establishing it as a felony, providing civil remedies for victims, and mandating educational awareness in schools and postsecondary institutions to protect vulnerable individuals, especially children and young people, from becoming victims of this growing crime.

Shortly after the passage of the bill, PATH Director of Programs, Jaime Thompson, joined a collaborative effort with Kentucky Youth Advocates (KYA), Exploited Children's Help Organization (ECHO), and Louisville Metro Police Department to begin work on awareness and education materials required by mandate in the legislation passed. The purpose of the team was to gather and craft the content for the *products* needed for disseminating evidence based information and guidance to Kentucky parents and caregivers, adults in charge of youth care and protection, and the young people themselves. Jaime was the lead researcher and a writer on this project, and worked with the team on a collaborative document to review, organize and edit content. KYA will feature this critical information on its website during the following months and the team is working to disseminate this information related to the mandated educational awareness through blogs, short videos, and printed information about the crime and where to get help if victimized.

 73 the Sextortion bill passed into law during the 2025 legislative session.
- Continued our work on SB73 by partnering with organizations to create the educational products needed to support the newly mandated legislation.
- Launched a Human Trafficking 101 FREE education module on our website. <u>Link to session.</u>
- Hosted 4 virtual seminars during January, 2025 Human Trafficking Awareness Month and conducted 5 in person trainings.
- Became an official partner of the Face It Movement to end child abuse.
- Hired a Director of Programs and Program Coordinator in a flexible capacity so that we can increase our in person and on-line educational offerings and initiatives.
- Welcomed 3 new board members in late 2024 and welcomed 5 more new board members at our annual meeting in August, 2025.
