Federal and State efforts to protect children online

In the May, July and September issues of this newsletter, we provided updates on the Kids Online Safety Act (KOSA). KOSA is the first federal legislation in over 25 years which attempts to protect children while they are online. KOSA passed the Senate but is still awaiting a vote in the House. This federal law would hold accountable big internet and tech companies by requiring them to "take reasonable measures in the design and operation of products or services used by minors to prevent and mitigate certain harms that may arise from that use".

Here in Kentucky, during the last legislative session in January and February, 2024, PATH partnered with The United Nations Association - Kentucky Division in attempting to get a sextortion law passed. Senate Bill 181 Sponsored by Senator Julie Raque Adams, SB181 sought to establish the crime of sexual extortion as a felony; include sexual extortion in the definition of "sex crime"; require superintendents of local school districts to notify students in grades 4 and above and parents and guardians of all students of the crime of sexual extortion; require local school boards to display posters in schools with the definition of sexual extortion and contact information for entities offering assistance to victims; and require postsecondary institutions to display posters with the definition of sexual extortion and contact information for entities offering assistance to victims in residence halls, classroom buildings, and student centers.

SB181 did not get out of committee last session but we are dedicated to working with United Nations Association - Kentucky Division to get this bill renewed and through our state legislature when the new session starts at the beginning of 2025. It is imperative we protect our children's online presence and usage. Watch this newsletter for more information and possible calls to action once the session begins.


On November 20th, PATH Vice Chair, Dr. Theresa Hayden, participated in the Mercy Academy Senior Capstone Community Day.
