Role	Member	Responsible for
President	Mick Pfeifer	Chairs meetings and exercises executive control over Club functions. Brings up issues of importance to the Club with external organizations such as DuPage County Forest Preserve, Naper Aero Airport and other R/C Clubs in the area.
Vice- President	Pete Fales	Manages the Club point system and publishes it in the January Club Newsletter, assists the President in his duties, and assumes the role of President during any absence. Acquires year-end auction items.
Secretary	Mike Pettinger	Records minutes of Club meetings, manages Club correspondence, and seeks permits for Club functions.
Treasurer	Bill Hickey	Manages all financial matters of the Club, collects dues and fees, pays Club debts and has primary stewardship of Club funds. Manages member database and processes new members. Tools – Techniques - Tips

Equations & Such – Propeller Load Factor

Ever wonder if a different size prop would help an airframe perform better?

There's an old rule of thumb that states that increasing prop pitch by an inch is equivalent to reducing the diameter by an inch. So, an 11x5 prop and a 10x6 prop are roughly equivalent with respect to the load they put on a motor. If you want more speed, change that 11x5 to 10x6. If you'd like to have an easier time slowing down for landing, change the 10x6 to 11x5. The motor won't care much either way.

That rule of thumb works well enough, but there is a better approach that isn't all that complicated. Turns out the load created by a propeller is basically a function of three things – the diameter, the pitch, and the number of blades. But while linearly proportional to pitch, when it comes to diameter the load is proportional to it cubed, and to the root of the blade count minus one:

$$PLF = D^3 \times P \times \sqrt{BC-1}$$

Where PLF is the propeller load factor, D is the propeller diameter, P is the propeller pitch, and BC is the propeller blade count.

Note that the load factor is normalized to two-bladed props, that is, for them the load factor is proportional to the pitch and diameter cubed. And the units don't really matter as long as one is consistent – I like to use inches, but if millimeters are your thing, go for it.

So, do an 11x5 and 10x6 prop put the same load on a motor? Not really:

Diameter	Pitch	Blades	PLF	Relative to 10x6
10	6	2	6,000	-0-
11	5	2	6,655	+9%

That 11x5 prop puts 9% greater load on the motor than the 10x6 prop. With a PLF of 5,990, an 11x4.5 prop would create a nearly identical load. Perhaps you're tired of cleaning grass off your trainer because it's running a 12x6 prop that mows a path to the runway. And you happen to have a 10x7.5x3 (three-bladed) prop:

Diameter	Pitch	Blades	PLF	Relative to 12x6
10	7.5	3	10,607	+2%
12	6	2	10,368	-0-

For just a 2% increase in load, the fuselage stays a lot cleaner.

So, give Equation 1 a try the next time you're considering a change in prop size.
