Ellen called the meeting to order at 7:01 pm.

Approval of Last Meeting Minutes – Motion to approve by Linda, seconded by Sara, all in favor, motion carried.

MSUE updates – David – Volunteer Central is closed, the system will reopen in March. EMGs keep track of hours earned now for input in March when Volunteer Central reopens. Recertification will start Jan 9th through 31st and late recertification fee will be Feb 1 – 10th. No training required this year for recertification. “On the Origin of Macomb County’s Soils— The Science Behind the Soil in Our Backyards”

January 16th, 2025

Presenter: Jim Selegean, Environmental Engineer
U.S. Army Corps of Engineers

The soils in our gardens are largely a product of processes that occurred at the end of the last ice age (~10,000 years ago). To better understand why there are orchards in Romeo and flat clayey landscapes across much of Macomb County, we need to examine the glacial history of the area. This lecture will also discuss some fundamentals of soil science (pH, organic matter, texture, etc.) and how to improve even the worst soils.

Jim has offered to analyze some soil samples following his presentation. We’d like to give priority to EMG projects, and if there’s time left, personal samples may be tested. If interested, please bring a small soil sample (2-3 table-spoons) to the meeting for testing.
