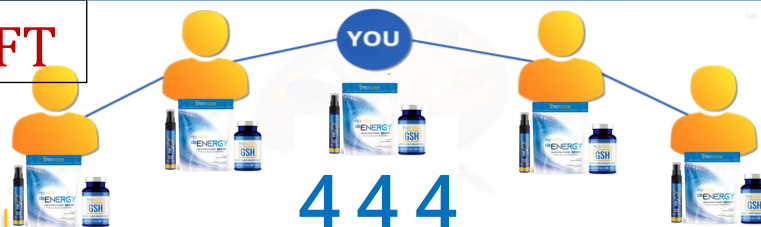


Cash Flow Examples

- \$69 Retail Price for GSH, ENERGY & KT Mist!
- Online Retail Orders: Receive 30% of price
- Personal Sales: Receive even more!

Per Unit Retail Profits \$69 - \$49 = \$20*

AFFILIATE SPONSOR Commissions (Paid Weekly)

When you enroll a new Provizion Global Affiliate you will receive up to 20% of their Product Volume PV anytime they order.

- 10% Sponsor Commissions are paid out for Affiliates with 25+PPV Qualification.
- 10% First Year Promo is paid on each new enrollee you Sponsor for their first year.

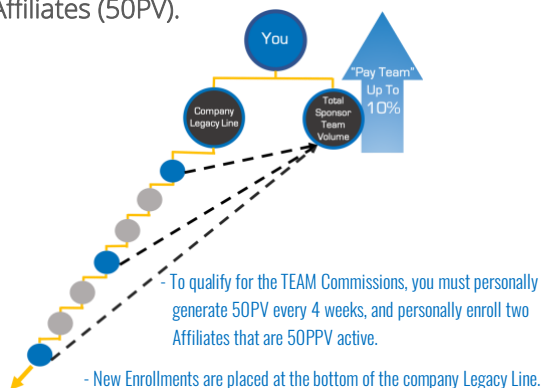
Title = Provizion Title and associated PV requirements. Wholesale Affiliates are Qualified with 25PPV and TeamTM Master & Legacy Affiliates are Qualified with 50PPV.
Team Affiliates = Number of personally sponsored Wholesale Affiliates required who have purchased 50pv or more in the last 4 weeks.
Minimum QSTV = Minimum Total amount of Qualified Sponsor Team Volume required to achieve each title.
Max QSTV/Team = Maximum QSTV counted as Qualified from any single Sponsor team. Additional QSTV must come from additional personally sponsored teams.
Team Payout Potential = The maximum Income that can be earned in a single week from Team Commissions (PayCap).
Generation Match = A 10% Match Pay on the Team Commissions of Affiliates you personally Sponsor and in their Teams for up to 4 generations with compression.
LegacyLine Potential Shares = Receive 1 Share for each sponsor team with 1000PV in a single week from our LegacyLine Pool containing 4% of the total company PV.

TEAM Commissions (Paid Weekly)

All Affiliates are placed in the Provizion Legacy Line according to Affiliate Registration date and time. Team Commissions are paid out as up to 10% of your Total Sponsor Team Volume. Must be Team Affiliate qualified with 1 or more Team Affiliates (50PV).



$\$20,000/\text{Wk} \times 52 \text{ weeks} = \$1,040,000/\text{year}$

GENERATION Commissions (Paid Weekly)

Based on your weekly Team Affiliate Title qualification and having 4 Active Affiliates at 50PV, you will receive a 10% MATCH on the Team Commissions from your Sponsor Team, including up to 4 levels deep with compression. Not to exceed 10% of Total Sponsor Volume.

Legacy Partner Incentive (Paid Monthly)

Sponsor Earnings on Packs are doubled when a qualified Team Affiliate personally Sponsors at least 2 new "Legacy Partners" or 4 new "Master Partners" within the same Calendar Month.

- Affiliate must have purchased their own Legacy or Master Pack within their last 52 weeks to qualify.

LegacyLine Incentive (Paid Weekly)

Receive 1 share of the LegacyLine Pool for each separate sponsor team that produces 1000 STV in a single week. You may earn an unlimited number of shares in the 4% LegacyLine Pool. These shares are multiplied by a factor of the percentage of total LegacyLine Volume below your LegacyLine position.
