Speaker - Collin County Sheriff Jim Skinner COLLIN COUNTY UPDATE

Collin County Sheriff Jim Skinner is a 32-year law-enforcement veteran, trial attorney, and former prosecutor. He took office on January 1, 2017, and oversees 550 personnel, who deliver services to over 1.1MM citizens across 880 square miles in the northeast quadrant of the Dallas/Fort Worth Metroplex. Like others, he recently lead his Office's response to the national emergency related to COVID-19 and is keeping an eye on a major project to renovate the intake, infirmary,

kitchen, and housing areas of the county jail. He's honored to have been designated as a subject-matter expert in connection with the work of the President's Commission on Law Enforcement and Administration of Criminal Justice. In January 2020, he was a panelist and speaker at the White House's summit on human trafficking and commemoration of the TVPA 2000. As Chair of the Legislative Committee of the Sheriffs' Association of Texas, Sheriff Skinner was proud to be a part of the efforts to persuade the people and the 86th Texas Legislature to pass a constitutional amendment and several statutes important to law enforcement, including SJR 32 and SB 2100 (2019), which improved the humane retirement of law-enforcement dogs and other service animals. And, in May 2018, he spoke, by invitation, at Texas Governor Greg Abbott's multi-disciplinary meeting in response to the May 18 Santa Fe High School shooting.

Since taking office, Sheriff Skinner has implemented several initiatives, including enlarging the Patrol Section to keep pace with County growth; starting a fugitive task force with assistance from the U.S. Marshal's Service and serving or clearing thousands of aging felony warrants; forming, with seven other sheriffs, the North Texas Criminal Interdiction Unit and arresting over 280 traffickers, seizing tons of illegal drugs, seizing several military-style weapons, seizing over \$6.9 million in bulk cash, stopping three loads of human cargo, recovering just over 110 stolen vehicles, and rescuing two missing children in separate traffic stops; forming a new detention intelligence unit and gathering intelligence from the county's 1,298-bed jail, including intelligence about gangs and drug cartels; and forming a child-exploitation unit that investigates internet-based child exploitation that has arrested 274 subjects on felony charges and seized terabytes of child pornography. Sheriff Skinner is also a member of county committees on courthouse security, jail population, and local mental-health care.

Sheriff Skinner is also an active member of the National Sheriffs' Association, where he sits on their Board of Directors and serves as the Chairman of the Government Affairs Committee. He is a member of the North Texas Crime Commission and a former member of its board of directors. He's a member of the board of the local Meals on Wheels as well.

Sheriff Skinner's career has spanned over 32 years in law enforcement. He has served as the Second Assistant District Attorney and Chief of the Special Prosecution Division of the Collin County Criminal District Attorney's Office. In 2008, he prosecuted a District Attorney from the DFW Metroplex for official corruption (15-year sentence). He also separately served as an Assistant District Attorney and Special Prosecutor in the Office. In private practice, he both consulted on the investigation of financial crimes and represented child victims of sex abuse from around the country.

Before graduating the University of Houston Law Center in 2001, Sheriff Skinner served as the Chief Investigator for New Mexico's Ninth Judicial District Attorney's Office and over 19 years as a police officer in New Mexico and Texas. He worked in homicide, robbery, burglary, gangs, narcotics, vice, white-collar crime, and public corruption.

Sheriff Skinner served our country for eight years as a U.S. Air Force Security Police Dog Handler, Investigator and EST (SWAT) Team Leader/Operator, stationed in Southeast Asia, New Mexico, and the Middle East.

THE WIT AND WISDOM OF SILENCE DOGOOD

DECEMBER 1, 2024

Benjamin Franklin, one of America's most celebrated Founding Fathers, began his public life not as a politician or inventor, but as a teenage satirist hiding behind the pen name "Silence Dogood." This pseudonym became his first foray into public discourse, showcasing his sharp wit, keen observations, and unrelenting desire to provoke thought. Franklin's adoption of the Silence Dogood persona not only cemented his future as a master communicator but also revealed his deeply personal struggles and the budding of his intellectual beliefs.

At just 16 years old, Franklin was an apprentice to his older brother James, who owned *The New-England Courant*, one of the earliest independent newspapers in the colonies. Their relationship was fraught with tension, primarily due to James's domineering attitude and Franklin's precocious intellect. Benjamin chafed under the restrictions of apprenticeship, longing for opportunities to contribute more than manual labor. However, James refused to publish anything from his younger brother's hand, likely dismissing his ideas as youthful and inconsequential.

Determined to bypass his brother's editorial gatekeeping, Franklin devised an ingenious solution: he would create a fictional character, Silence Dogood, to express his views. Portrayed as a middle-aged widow, Silence embodied a persona that was relatable, modest, and unassuming - qualities that allowed her bold critiques to fly under the radar. Franklin secretly submitted the letters to *The New-England Courant*, slipping them under the door of the print shop at night. To Ben's delight, James published the letters, completely unaware of their true author.

The ruse lasted until Franklin revealed his identity, which led to an explosive confrontation. James, furious at being deceived, responded harshly, and the already-strained relationship between the brothers deteriorated further. This fallout played a significant role in Franklin's eventual departure from his apprenticeship and set the stage for his pursuit of independence.

Between April and October of 1722, Franklin wrote 14 Silence Dogood letters, covering topics ranging from religion and education to the follies of colonial society. Though written under the guise of a widow, the letters are unmistakably infused with Franklin's sharp intellect, humor, and budding Enlightenment ideals.

One of the central themes in these letters is education. In Letter No. 7, Franklin, through Silence, critiques the shortcomings of the colonial education system, lamenting its neglect of virtue and intellectual rigor. He warns of the dangers of ignorance, emphasizing the importance of shaping young minds through proper instruction. Franklin's belief in the transformative power of education would remain a cornerstone of his later work, from founding libraries to creating academies that evolved into modern universities.

Franklin also used the letters to challenge societal norms and hypocrisy. In Letter No. 4, for example, Silence humorously critiques drunkenness, suggesting exaggerated remedies such as assigning women the task of governing men's behavior or making bitter concoctions to deter overindulgence. Beneath the humor lies a deeper commentary on personal responsibility and the importance of temperance - values Franklin would later champion in his own life through his famous virtues.

The Silence Dogood letters also reflect Franklin's evolving views on liberty and power. Although couched in satire, the critiques in these letters highlight Franklin's disdain for oppression, both in religious and political contexts. He mocks pompous preachers and unqualified leaders, subtly laying the groundwork for the democratic principles that would guide his later activism.

What makes Franklin's Silence Dogood letters remarkable is how they reflect his personal philosophy even at a young age. Franklin's disdain for authority figures who wielded power unjustly was evident in his critiques of religious and political leaders. As Silence, he boldly questioned the integrity of those entrusted with guiding others, an attitude that presaged his later commitment to civic virtue and accountability in public life.

The letters also reveal Franklin's pragmatism and humanism. Silence's humorous tone made her critiques accessible and engaging, embodying Franklin's belief that persuasion is best achieved through wit and reason. This approach would become a hallmark of Franklin's public persona, allowing him to address controversial topics without alienating his audience.

Moreover, the Silence Dogood letters demonstrate Franklin's enduring optimism about human potential. Whether advocating for education or mocking societal flaws, Franklin's underlying message was one of self-improvement and progress. He believed deeply in the ability of individuals - and by extension, society - to grow and flourish through knowledge, discipline, and shared effort.

The Silence Dogood letters were more than just a teenager's clever prank; they were the foundation of Franklin's career as a writer, thinker, and reformer. The experience of creating Silence taught Franklin the power of the written word to influence public opinion and spark change. It also allowed him to explore ideas that would shape his later contributions to American society, from his aphorisms in *Poor Richard's Almanack* to his involvement in drafting the Declaration of Independence.

In retrospect, Silence Dogood was not merely a character but a vessel through which Franklin's youthful ideas took form. The letters, with their humor, insight, and boldness, capture the essence of Franklin's genius. They remind us that even in his early years, Franklin possessed the qualities that would define him: a relentless curiosity, a commitment to improvement, and an unshakable belief in the power of ideas.

In addition to Silence Dogood, Benjamin Franklin famously adopted other female pseudonyms throughout his writing career, showcasing his creativity and his strategic use of alternative personas to challenge societal norms. One notable example was Polly Baker, a fictional woman Franklin invented to deliver a satirical critique of colonial laws and attitudes toward single motherhood. In a fictional speech attributed to Polly, Franklin cleverly highlighted the injustice of punishing women for having children out of wedlock while ignoring the culpability of men, a commentary on the gender inequalities of the time. By writing from the perspective of women, Franklin could approach sensitive or controversial topics in a way that allowed readers to engage with them more openly, often under the guise of humor or relatability. These personas reflected his skill in adopting diverse perspectives to push boundaries, question authority, and advocate for fairness and reform in an era where such ideas were still taking shape.

Franklin's journey from an apprentice hiding behind a pseudonym to one of the most celebrated figures in American history is a testament to the transformative power of intellect and perseverance. Silence Dogood and other women's pseudonyms he used may have been fictional, but the truths they spoke and the values they championed were undeniably real - echoes of a young man whose voice would soon shape a nation.

Too many American voters are disgusted with failures emanating from progressivism's toxic political ideology.

Even notoriously liberal areas in the last two years have tried to reverse the most insane of their destructive policies. Democratic lemmings ignored the warning signs and marched off of the left-leaning cliff anyway.

In July of 2022, San Francisco District Attorney Chesa Boudin was ousted.

In the 2024 Democratic primaries, Squad members Reps. Jamaal Bowman of New York and Cori Bush of Missouri were bounced from the U.S. House.

While an overwhelming majority of the electorate was fed up with "The Squad," the chronically tone-deaf Harris campaigned the day before the election in New York with original Squad darling Rep. Alexandria Ocasio-Cortez, D-N.Y.

On election day 2024, former San Francisco and current Los Angeles District Attorney George Gascon suffered a landslide election blowout.

Former New York Congressman Mondaire Jones's comeback attempt failed badly. Far left Sens. Sherrod Brown, D-Ohio, and Jon Tester, D-Montana, will no longer be voting against the will of their deeply conservative constituents.

Both were shown the door by wide margins. Despite being given \$100 million by outside interests, Rep. Collin Allred, D-Texas, soundly lost his Texas Senate bid to incumbent Sen. Ted Cruz, R-Texas.

Progressive policies were being reversed to stem the tide of future election losses.

Four years after legalizing all drugs, Oregon voted to recriminalize hard drug use.

The 2020 maneuver by Alaska Democrats to rig future elections through rank choice voting was narrowly repealed.

Attempts by Democrats in Colorado, Montana, Nevada, and Oregon to install the rank choice voting scheme were defeated.

Anti-crime measures in Arizona, California and Colorado all passed.

Efforts to legalize recreational marijuana failed in Florida, North Dakota and South Dakota.

Even Massachusetts, the American bastion of liberalism, voted against legalizing psychedelic drugs by a 15 -point margin.

California's initiative to raise the state minimum wage from \$15 to \$18 per hour failed.

Uber-left Washington State voters passed an initiative banning their state government from restricting access to natural gas.

While blue states were shifting into reverse, red states were happy to hit the accelerator to advance conservative policies and run over leftist ones.

Kentucky voted to allow state funding of non-public schools. Kansas voted to force Kansas City

to *refund* their police. Attempts to ban non-citizens from voting won by landslides.

At least 62% of voters in eight states approved ballot measures banning this practice, with 86% of South Carolina voters favoring the prohibition.
