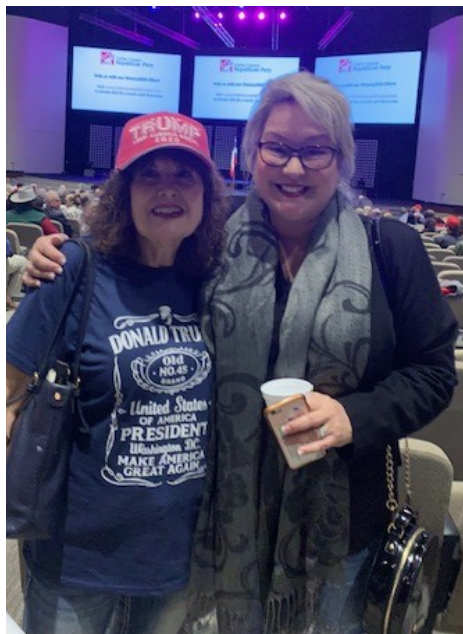

AMERICANISM REPORT

Women's Right to Vote

As PRW prepares for the 2020 election battle by registering voters and working the polls we may be surprised to find out that we women have only had that right for 100 years.

Women finally got the right to vote when the 19th amendment passed in 1920 after a seventy plus year battle. The charge was led by Susan B. Anthony (1820-1906) when she joined the temperance, suffrage, and antislavery movements in the 1850s. At the time of her death, four states had granted women the right to vote. Fourteen years after her death, the movement finally won passage of the Nineteenth Amendment, giving women equal voting rights nationwide.

Ms. Anthony did get to vote and was arrested in 1872 for voting in the Presidential election. She was fined \$100 but she refused to pay the fine.

By the way she voted the Republican ticket. She backed Ulysses S. Grant rather than the first ever female candidate. Victoria Woodhull. Ms. Anthony was considered by sum to be a prude and Victoria Woodhull was free spirited.

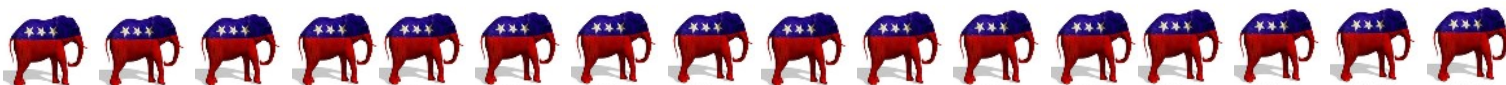
After the passage of the 19th amendment the measure needed to be ratified by 36 states to become law. By the end of summer 1920, the supporters of the amendment were one state from victory and that was the state of Tennessee. Tennessee was expected to vote against the amendment like the other southern states did.

A man named Harry Burn from Tennessee was expected to vote nay. He even wore a red rose in his lapel. The red rose was the symbol of the antisuffragists. However, the morning of the Tennessee roll call, Burn received a letter from his mother. She implored him to "be a good boy" and vote for the amendment.

When Burn's name was called, he voted "aye" in a soft voice that was barely audible. It was shocking to his fellow southerners.

Burns said, "I believe we had a moral and legal right to ratify." He did admit that he knew that "a mother's advice is always safest for her boy to follow and my mother wanted me to vote for ratification."

Mom knew best!

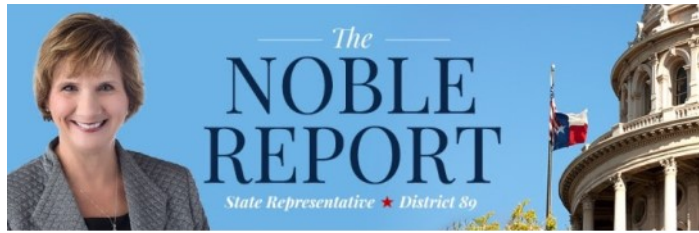

Legislative Report



Since my last Noble Report I've made some trips to Austin, I've met with a lot of folks, and well, I'm running for office. The interim has been a busy time.

I'm going to try to explain some complex issues in this edition of the Noble Report. These subjects are not easy, but I've done my best to simplify them for you below.

Earlier this month, I served on a panel for the Texas Conservative Coalition Research Institute's Tax Competitiveness Policy Summit in Austin. I love innovation and the vision that our private business sector provides. There are so many new ways to sell goods and services. While we want to encourage new ventures, it is important when dealing with government regulations and sales taxing, that the playing field is level ground for both the new and the more traditional established businesses in the same market.

The Competitiveness Panel was dealing with just two of those marketplace innovations. The first industry and changing marketplace that we studied was the hotel industry. Next, we looked at the car rental business and changes within that industry.

In the hotel industry, the online platforms (like Expedia & Travelocity) sell nights on behalf of the hotels. A consumer can also call or walk into a hotel directly to make a reservation, or use the hotel chain's booking sites. So the question is: What is the actual cost of the hotel room to the traveler? What is the tax assessed on that room? If you use an online platform, you will see something like "Taxes and Fees" on top of the hotel room's cost when you go to the checkout page. I, like most travelers, assume those are mostly taxes and a few dollars of fees. Not necessarily. It would be almost impossible for any auditor to see if the correct amount of taxes had been collected. I'm fine with the hotel having an agreement with the online service to fill their empty rooms. But I think it is only fair in these online platforms, for the sake of transparency, to show the customer the actual amount of taxes paid and list separately the fees assessed on that transaction.

The other industry that is quickly changing is the short-term car rental arena. You can now rent a car from a neighbor on an online "peer to peer" platform. These online sites are not collecting sales tax as the traditional car rental locations are required to do. The peer rental sites think they should be exempt from collecting any sales tax. The question is: should it be any different for the customer to pay a car rental sales tax when they rent from Enterprise or Alamo versus when they rent from another online source? Does it make a difference that it is not a business that owns the car? It was a very lively debate!

Another trip to Austin was for the Interim Ways and Means Committee Hearing. While the Legislature passes laws, it is up to state agencies to write the rules that enforce those laws. At this meeting, we had an update from Comptroller Glenn Hegar and his staff on the rules concerning the collection of sales tax from online sale of goods.

Here's the debate: Should a business that only sells online (no physical store location to walk into and purchase goods) collect the sales tax for where the business is located or where the goods are delivered? The "Wayfair Decision" (out of the federal judicial system) made it clear that we may charge a sales tax on goods purchased outside of Texas when they are shipped here. The bill that addressed this change was House Bill 2153. During the hearings on HB 2153 it was made clear to me that an online sales tax collected from vendors outside of Texas would go to the city where the goods were being delivered. This is very important to me, because it lessens the burden on local property taxes to provide for local roads and other infrastructure. Now the question is: if the goods are manufactured or stored in a warehouse inside of Texas and are sold and shipped to a Texas address, then who should get that sales tax?

You see, there are approximately a dozen cities in Texas with agreements with businesses located within their city. These are a type of "380 Agreements." These cities get all the sales tax from that business (regardless of where the goods are delivered), and then remit a portion of that sales tax back to the business. Round Rock has had this arrangement with Dell Computers since they moved to that city back in the 1980's, so if you have bought a Dell Computer straight from the company, you've paid sales tax to Round Rock. Some cities give as much as 75% of the sales tax collected by a business back to that business, with the remaining portion being retained by the city. As you can imagine, these few cities are worried that tax dollars they have been getting will now be going to other cities, and several of them came to Austin to testify against the proposed rule's implementation. The proposed Comptroller rule will benefit most cities (especially rural ones) while causing a big loss of local sales tax revenue to a few cities. This issue resulted in a long and lively debate.

On a personal note, I was honored to be awarded the "Defender of the American Dream" Award from Americans for Prosperity for my work on Senate Bill 2's historic property tax reform. I was presented with a big beautiful engraved Bowie knife! Now to figure out how to safely display it (I have eight grandchildren, after all.)

Finally, I wanted to remind you that early voting for the Primary is available through Friday (Feb. 27) from 7am till 7pm each day. For those that don't early vote, Super Tuesday is one week from today and voting locations are open from 7am-7pm that day. If you live in House District 89, I'd be honored to have your vote.

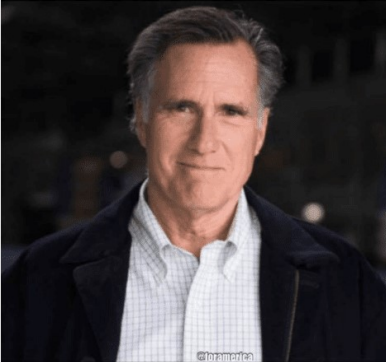

Ted Cruz Demolishes Mayor Pete's Malicious Lie About the Founders and Slavery

Speaking to schoolchildren, 2020 Democrat Mayor Pete Buttigieg insisted that the authors of the Constitution "did not understand that slavery was a bad thing." Sen. Ted Cruz (R-Texas) demolished this claim with direct quotes from the Founders, who very much understood the evil of slavery but compromised on the issue in order to keep the early United States together.

Buttigieg addressed the amendment process, saying that the Founders "were wise enough to realize that they didn't have all the answers and that some things would change. A good example of this is something like slavery or civil rights. It's an embarrassing thing to admit but the people who wrote the Constitution did not understand that slavery was a bad thing."

Mayor Pete was correct that the Founders instituted the amendment process in the Constitution partially because they were humble enough to realize things would change. In fact, the amendment process is the correct way for the government to recognize new rights, not Supreme Court interventions like *Roe v. Wade* (1973).

However, Buttigieg was entirely off base to suggest the Founders did not understand the evils of slavery. In fact, many of them acknowledged the evils of slavery, but they compromised in order to hold the new nation together. As Matt Spalding wrote for the Heritage Foundation, "Those who founded this nation chose to make practical compromises for the sake of establishing in principle a new nation dedicated to the proposition that all men are created equal."

Ted Cruz rebuked Buttigieg by posting a string of direct quotes from the Founders.

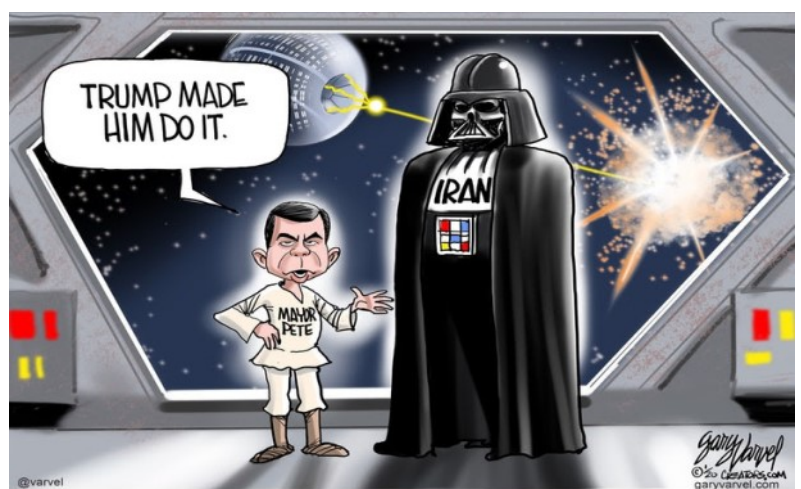
"Slavery is an evil of Colossal magnitude & I am utterly averse to the admission of slavery into the Missouri Territories. It being among my first wishes to see some plan adopted by which slavery in this country may be abolished by law," Cruz quoted from John Adams, a Founding Father and the second president.

"Freedom is not a gift bestowed upon us by other men, but a right that belongs to us by the laws of God and nature," he quoted from Benjamin Franklin, who was a member of an abolitionist society. "Neither my tongue, nor my pen, nor purse shall be wanting to promote the abolition of what to me appears so inconsistent with humanity and Christianity."

"Who talks most about freedom and equality? Is it not those who hold a bill of Rights in one hand and a whip for affrighted slaves in the other?" Cruz quoted from Alexander Hamilton, an abolitionist and the first secretary of the Treasury.

"It is much to be wished that slavery may be abolished," John Jay, the first Chief Justice of the Supreme Court, wrote. "The honor of the States as well as justice and humanity, in my opinion, loudly call upon them to emancipate these unhappy people. ... To contend for our own liberty, and to deny that blessing to others, involves an inconsistency not to be excused."

Lathan Watts: Our greatest presidents believed in religious liberty - Americans should preserve their legacy

President's Day began as a day to celebrate and commemorate the life and unmatched character and achievements of George Washington, who was born Feb. 22, and later, Abraham Lincoln, born Feb. 12.

Though the modern observance of President's Day, the third Monday of February, is more general in nature, most still use the occasion to reflect on the contributions of Washington and Lincoln. Despite the years and momentous history between their lives and administrations, their legacies are inextricably linked.

No two men in American history served the nation in more perilous times.

FROM WASHINGTON TO TRUMP, MOST PRESIDENTS HAVE BEEN CHRISTIAN

Leading our nation through its darkest periods proved to be a nearly unbearable burden on both men, yet each is celebrated. Despite very different upbringings and theological backgrounds, it was a common faith in God that sustained them through the lowest points.

Washington and Lincoln spoke publicly and wrote extensively about their faith and the role of religion in a free society. Ironically, today some attempt to use the Constitution written at a convention over which Washington presided to exorcise all references to faith from the public square, ban the faithful from public office, and relegate religious liberty to the smallest corner of the American mind never to be spoken or lived outside houses of worship.

In 1789, Washington addressed the General Committee representing the United Baptist Churches of Virginia, but the prescience of his words speaks to the attacks on religious liberty today:

If I could have entertained the slightest apprehension that the Constitution framed by the Convention, where I had the honor to preside, might possibly endanger the religious rights of any ecclesiastical Society certainly I would never have placed my signature to it; ...I beg you will be persuaded that no one would be more zealous than myself to establish effectual barriers against every species of religious persecution.

Imagine the reaction from today's secularist zealots if a president sent a message to every governor similar to the one Washington sent to governors at the close of the Revolutionary War:

I now make it my earnest prayer that God would have you, and the State over which you preside, in his holy protection ... that he would most graciously be pleased to dispose us all to do justice, to love mercy, and to demean ourselves with that charity, humility, and pacific temper of mind, which were the characteristics of the Divine Author of our blessed religion, and without an humble imitation of whose example in these things, we can never hope to be a happy nation.

In 1863, during the height of the Civil War, Lincoln issued a formal proclamation, passed by an act of Congress, initiating the first annual National Day of Thanksgiving. Notably, Lincoln's proclamation is keenly focused on to whom Americans should be grateful as opposed to what they should be grateful for:

I do, therefore, invite my fellow citizens in every part of the United States, and those who are sojourning in foreign lands, to set apart and observe the last Thursday of November next as a day of Thanksgiving and Praise to our beneficent Father who dwelleth in the heavens ... (it is) announced in the Holy Scriptures and proven by all history, that those nations are blessed whose God is the Lord. ... It has seemed to me fit and proper that God should be solemnly, reverently and gratefully acknowledged, as with one heart and one voice, by the whole American people.

Merely reading a statement like that in a public school in America today could cost a teacher their job.

Washington and Lincoln stand as towering figures in American history. The freedom they both cherished so deeply and for which they sacrificed so greatly is under attack not from foreign despots, but from within. As we pause to remember these two great patriots, let each of us recommit ourselves to the cause of liberty and to reliance on the Author of liberty for ultimate victory.

Communist Rules For Revolution


- A. Corrupt the young, get them away from religion. Get them interested in sex. Make them superficial, destroy their ruggedness.
- B. Get control of all means of publicity and thereby:
 1. Get people's minds off their government by focusing their attention on athletics, sexy books and plays and other trivialities.
 2. Divide the people into hostile groups by constantly harping on controversial matters of no importance.
 3. Destroy the people's faith in their natural leaders by holding the latter up to contempt, ridicule and obloquy.
 4. Always preach true democracy, but seize power as fast and as ruthlessly as possible.
 5. By encouraging government extravagance, destroy its credit; produce fear of inflation with rising prices and general discontent.
 6. Foment unnecessary strikes in vital industries, encourage civil disorders and foster a lenient and soft attitude on the part of government toward such disorders.

7. By specious argument cause the breakdown of the old moral virtues, honesty, sobriety, continence, faith in the pledged word, ruggedness.

C. CAUSE THE REGISTRATION OF ALL FIREARMS ON SOME PRETEXT, WITH A VIEW TO CONFISCATING THEM AND LEAVING THE POPULATION HELPLESS.

Cleon Skousen was an FBI special agent until 1951. He then taught at BYU and became Salt Lake City's police chief in 1956. His classic book *The Naked Communist* included a 45 point summary of their subversive agenda in the USA. Many sources date this list to 1963, when it was read into the Congressional record. However, the book's first copyright date was 1958, well before the mid-1960s when these changes took the public by surprise.

Communist goals of 1958

Items 1-14 concerned enhancing the position of the USSR and other Communist nations. Here's the domestic agenda:

15. Capture one or both of the political parties in the United States.
16. Use technical decisions of the courts to weaken basic American institutions by claiming their activities violate civil rights.
17. Get control of the schools. Use them as transmission belts for socialism and current Communist propaganda. Soften the curriculum. Get control of teachers' associations. Put the party line in textbooks.
18. Gain control of all student newspapers.
19. Use student riots to foment public protests against programs or organizations which are under Communist attack.
20. Infiltrate the press. Get control of book-review assignments, editorial writing, policy-making positions.
21. Gain control of key positions in radio, TV, and motion pictures.
22. Continue discrediting American culture by degrading all forms of artistic expression. An American Communist cell was told to "eliminate all good sculpture from parks and buildings, substitute shapeless, awkward and meaningless forms."
23. Control art critics and directors of art museums. "Our plan is to promote ugliness, repulsive, meaningless art."
24. Eliminate all laws governing obscenity by calling them "censorship" and a violation of free speech and free press.
25. Break down cultural standards of morality by promoting pornography and obscenity in books, magazines, motion pictures, radio, and TV.
26. Present homosexuality, degeneracy and promiscuity as "normal, natural, healthy."

27. Infiltrate the churches and replace revealed religion with “social” religion. Discredit the Bible and emphasize the need for intellectual maturity which does not need a “religious crutch.”
28. Eliminate prayer or any phase of religious expression in the schools on the ground that it violates the principle of “separation of church and state.”
29. Discredit the American Constitution by calling it inadequate, old-fashioned, out of step with modern needs, a hindrance to cooperation between nations on a worldwide basis.
30. Discredit the American Founding Fathers. Present them as selfish aristocrats who had no concern for the “common man.”
31. Belittle all forms of American culture and discourage the teaching of American history on the ground that it was only a minor part of the “big picture.” Give more emphasis to Russian history since the Communists took over.
32. Support any socialist movement to give centralized control over any part of the culture—education, social agencies, welfare programs, mental health clinics, etc.
33. Eliminate all laws or procedures which interfere with the operation of the Communist apparatus.
34. Eliminate the House Committee on Un-American Activities.
35. Discredit and eventually dismantle the FBI.
36. Infiltrate and gain control of more unions.
37. Infiltrate and gain control of big business.
38. Transfer some of the powers of arrest from the police to social agencies. Treat all behavioral problems as psychiatric disorders which no one but psychiatrists can understand [or treat].
39. Dominate the psychiatric profession and use mental health laws as a means of gaining coercive control over those who oppose Communist goals.
40. Discredit the family as an institution. Encourage promiscuity and easy divorce.
41. Emphasize the need to raise children away from the negative influence of parents. Attribute prejudices, mental blocks and retarding of children to suppressive influence of parents.
42. Create the impression that violence and insurrection are legitimate aspects of the American tradition; that students and special-interest groups should rise up and use “united force” to solve economic, political or social problems.
43. Overthrow all colonial governments before native populations are ready for self-government.
44. Internationalize the Panama Canal.
45. Repeal the Connally reservation so the United States cannot prevent the World Court from seizing jurisdiction [over domestic problems. Give the World Court jurisdiction] over nations and individuals alike.

Does any of this sound familiar?

Along with elements of the traditional subversion script, this shows clear influences of suicidalism and cultural Marxism, though missing a few notable agendas. Back in 1958, surely these predictions must’ve seemed merely like “McCarthyism”. Skousen got much criticism for his views. Clearly he wasn’t just blowing smoke, though; *most items were partially or completely fulfilled*. Did this really “just happen” all by itself, with the heat suddenly turning way up during the mid-1960s? Like Cassandra of Troy, he was a prophet ignored until it was too late.

The two parties didn’t become Communist, of course. However, the Democratic Party—formerly the working man’s party—was co-opted by cultural Marxism, and the Republicans became a controlled opposition. The educational system got pozzed out. So was the media, and I doubt it took much convincing to get them on board.

American culture—literature, art, history books, and religion—became remarkably different from that of times past; which would've been hardly recognizable to our forebears. Lawyerly activism got agendas 16 and 28 fulfilled with judicial scrupulosity, and assisted with some others. Recently the GLBT crowd got everything they wanted, though likely they're thinking of new demands. Feminism burnt our social environment to cinders.

As for items *not* fulfilled, number 38 is quite alarming; it would've abrogated all semblance of due process and sent us straight to Kafka-land. Social agencies have tight integration with police, but quite fortunately don't have direct powers of arrest. Item 45 would've been very ominous too. Some still think it would be wonderful to surrender our sovereignty to the corrupt UN, our wannabe world government.

Was *all* this accomplished by Soviet agents and Communist subversives? No, they had plenty of "useful idiots" to help do their work for them. All it took was the "long march through the institutions" to get into influential positions, put the ideas into the public sphere, and convince others that all this was "social justice". As Yuri Bezmenov put it:

...the demoralization now reaches such areas where previously not even comrade Andropov and all his experts would even dream of such a tremendous success. Most of it is done by Americans to Americans thanks to lack of moral standards.

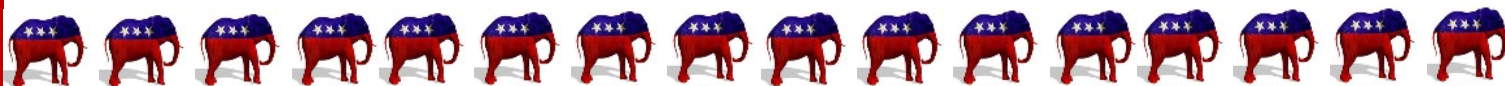
Class-based Marxism-Leninism is a spent force. The few remaining Communist nations are hanging by a thread. Thus, the foreign policy points from items 1-14 (omitted for length) have little emphasis now. Unfortunately, today's progressives still push "Communism Lite".

There's been little effort (yet) to roll back domestic measures, although the USSR—their reason for existence—ended in 1991. In fact, unless you've been living under a rock, you'll notice that many still are promoted quite actively. *This wouldn't have surprised Skousen very much.* Powerful groups still find progressive ideology useful to control the public. As a biographical summary noted:

Skousen's further studies eventually led him to conclude—like fellow anticommunist Robert Welch—that the communists were not the principals in the conspiracy to destroy America; they were merely the most visible arm of a much larger conspiracy. This conspiracy was run by a group of super-rich investment bankers from around the world who manipulated political agendas and public opinion to suit their own ends.

Proof of the elites' influence and their power structure was found in a book by Dr. Carroll Quigley, a professor of history at the Foreign Service School of Georgetown University, called *Tragedy and Hope*. Quigley was a member of the elitist Council on Foreign Relations. He had many personal connections with the super-rich and could trace their financial dealings in detail.

Those who declared victory with the USSR's collapse did so prematurely, since tricky globalist billionaire clubs are promoting much of the same these days, enforcing cultural Marxism through the media and other institutions. The more things change, the more they stay the same.
